
A BILL FOR AN ACT

RELATING TO CAPITAL IMPROVEMENT PROJECTS FOR THE BENEFIT OF THE
FORTY-FIRST REPRESENTATIVE DISTRICT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The director of finance is authorized to issue
2 general obligation bonds in the sum of \$122,600,000 or so much
3 thereof as may be necessary and the same sum or so much thereof
4 as may be necessary is appropriated for fiscal year 2020-2021
5 for the purpose of capital improvement projects for the forty-
6 first representative district, as follows:

7 1. East Kapolei middle school, Oahu
8 Design, construction, and equipment for
9 phase three construction; ground and
10 site improvements; and equipment and
11 appurtenances.

12 Design	\$500,000
13 Construction	\$25,000,000
14 Equipment	\$500,000
15 Total funding	\$26,000,000



1 The sum appropriated for this capital improvement project
2 shall be expended by the department of education.

3 2. Ewa Beach performing arts center, Oahu
4 Plans, land aquisition, design,
5 construction, and equipment for phase
6 one of a new performing arts center;
7 ground and site improvements; equipment
8 and appurtenances.

10	Land	\$1,000
11	Design	\$1,498,000
12	Construction	\$20,000,000
13	Equipment	\$1,000
14	Total funding	\$21,600,000

15 The sum appropriated for this capital improvement project
16 shall be expended by the department of education.

17 3. James Campbell high school, Oahu
18 Plans, design, and construction for
19 four athletic locker rooms, two
20 physical education locker rooms, ten

1 classrooms on top of locker rooms, and
 2 tennis courts.

7 The sum appropriated for this capital improvement project
 8 shall be expended by the department of education.

9 SECTION 2. The appropriation made for the capital
 10 improvement projects authorized by this Act shall not lapse at
 11 the end of the fiscal year for which the appropriation is made;
 12 provided that all moneys from the appropriation unencumbered as
 13 of June 30, 2022, shall lapse as of that date.

14 SECTION 3. This Act shall take effect on July 1, 2020.
