
A BILL FOR AN ACT

RELATING TO CAPITAL IMPROVEMENT PROJECTS FOR THE BENEFIT OF THE
FORTIETH REPRESENTATIVE DISTRICT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The director of finance is authorized to issue
2 general obligation bonds in the sum of \$37,560,000 or so much
3 thereof as may be necessary and the same sum or so much thereof
4 as may be necessary is appropriated for fiscal year 2019-2020
5 for the purpose of capital improvement projects for the fortieth
6 representative district, as follows:

16 SECTION 2. The appropriation made for the capital
 17 improvement projects authorized by this Act shall not lapse at
 18 the end of the fiscal biennium for which the appropriation is
 19 made; provided that all moneys from the appropriation that are
 20 unencumbered as of June 30, 2022, shall lapse as of that date.



1 SECTION 3. The sum appropriated shall be expended by the
2 designated expending agency for the purposes of this Act.

3 SECTION 4. This Act shall take effect on July 1, 2019.
