RELATING TO PUBLIC EMPLOYMENT COST ITEMS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 **PART I**

2 SECTION 1. There are appropriated or authorized from the
3 sources of funding indicated below to collective bargaining
4 statewide (BUF 102) the following sums, or so much thereof as
5 may be necessary, to fund for fiscal biennium 2019-2021 all
6 collective bargaining cost items in the agreement negotiated
7 with the exclusive representative of collective bargaining unit
8 (8):

7 chapter 89C, Hawaii Revised Statutes, for state officers and
8 employees who are excluded from collective bargaining and belong
9 to the same compensation plans as those officers and employees
10 within bargaining unit (8):

6 SECTION 6. Funds appropriated or authorized by this Act
7 that are not expended or encumbered by June 30, 2020, and June
8 30, 2021, of the respective fiscal years, shall lapse as of
9 those dates.

10 SECTION 7. This Act shall take effect on July 1, 2019.
