# A BILL FOR AN ACT

RELATING TO CAPITAL IMPROVEMENT PROJECTS FOR THE BENEFIT OF THE  
NINTH SENATORIAL DISTRICT.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1           SECTION 1. The director of finance is authorized to issue  
2 general obligation bonds in the sum of \$8,515,686 or so much  
3 thereof as may be necessary, and the same sum or so much thereof  
4 as may be necessary is appropriated for fiscal year 2020-2021  
5 for the purpose of capital improvement projects for the ninth  
6 senatorial district, as follows:

- 7       1. Kaiser Complex (Aina Haina Elementary  
8           School, Hahaione Elementary School,  
9           Kamiloiki Elementary School, Koko Head  
10          Elementary, Niu Valley Middle School,  
11          Kaiser High School)

12       A. Air conditioning for two hundred  
13           thirty-six classrooms.

9 SECTION 2. The appropriations made for the capital  
10 improvement projects authorized by this Act shall not lapse at  
11 the end of the fiscal year for which the appropriations are  
12 made; provided that all moneys from the appropriations that are  
13 unencumbered as of June 30, 2022, shall lapse as of that date.

14 SECTION 3. The sums appropriated for the respective  
15 capital improvement projects set forth in section 1 shall be  
16 expended for the purposes of this Act as follows:

- 17 (1) The sums appropriated in items 1 through 5 shall be
- 18 expended by the department of education; and
- 19 (2) The sum appropriated in item 6 shall be expended by
- 20 the University of Hawaii.
