A BILL FOR AN ACT

RELATING TO CAPITAL IMPROVEMENT PROJECTS FOR THE BENEFIT OF THE
NINETEENTH SENATORIAL DISTRICT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The director of finance is authorized to issue
2 general obligation bonds in the sum of \$78,760,000 or so much
3 thereof as may be necessary and the same sum or so much thereof
4 as may be necessary is appropriated for fiscal year 2020-2021
5 for the purpose of financing capital improvement projects for
6 the nineteenth senatorial district, as follows:

7 1. To be expended by the department of transportation:

8 A. Fort Weaver road, Oahu

9 Construction related to road

10 improvements and extension of

11 Keaunui drive to Renton road.

12 Construction \$34,000,000

13 Total funding \$34,000,000

14 2. To be expended by the university of Hawaii:

15 A. University of Hawaii, West

5 SECTION 2. The appropriation made for the capital
6 improvement projects authorized by this Act shall not lapse at
7 the end of the fiscal biennium for which the appropriation is
8 made; provided that all moneys from the appropriation that are
9 unencumbered as of June 30, 2022, shall lapse as of that date.

10 SECTION 3. The sum appropriated shall be expended by the
11 designated expending agency for the purposes of this Act.

12 SECTION 4. This Act shall take effect on July 1, 2020.
