# A BILL FOR AN ACT

RELATING TO HEALTH.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1           SECTION 1. The legislature finds that Alzheimer's disease  
2 is a medical condition that falls within the National Center of  
3 Chronic Disease Prevention and Health Promotion's definition of  
4 a chronic disease, as it is a condition that lasts one or more  
5 years, requires ongoing medical attention, and limits the  
6 activities of daily living. The legislature further finds that,  
7 per the report, *Hawaii 2025: State Plan on Alzheimer's Disease*  
8 *and Related Dementias*, published in 2013 by the executive office  
9 on aging, this disease is the sixth leading cause of death in  
10 the United States and affects twenty-seven thousand Hawaii  
11 residents, a number that will increase by more than forty per  
12 cent by the year 2025. The legislature also finds that Hawaii  
13 does not currently treat Alzheimer's disease as a chronic health  
14 condition and does not have a dementia-specific position within  
15 the chronic disease prevention and health promotion division of  
16 the department of health.



1           The division is tasked with promoting wellness and  
2 improving the quality and years of life of Hawaii's people  
3 through effective prevention, detection, and management of  
4 chronic diseases. The programs created by the division utilize  
5 public health strategies including strategic partnership  
6 development and community linkages; awareness and education;  
7 surveillance; evidence-based best practices; evaluation;  
8 promoting health equity; and public health policies. Persons  
9 who suffer from Alzheimer's and other forms of dementia, as well  
10 as their caretakers, require strong community support and  
11 education to assist them in living with and combating this  
12 chronic disease. Providing early detection and establishing  
13 education and awareness programs is crucial to addressing health  
14 inequalities within communities, and the legislature is  
15 concerned that the failure to appropriately classify Alzheimer's  
16 disease and provide a dementia-specific staff member within the  
17 division has led to a disparity in the quality and availability  
18 of care provided in Hawaii.

19           The purpose of this Act is to make an appropriation for an  
20 Alzheimer's disease and related dementia services coordinator  
21 position.



# S.B. NO. 676

1 SECTION 2. There is appropriated out of the general  
 2 revenues of the State of Hawaii the sum of \$ or so much  
 3 thereof as may be necessary for fiscal year 2019-2020 and the  
 4 same sum or so much thereof as may be necessary for fiscal year  
 5 2020-2021 for the establishment of one full-time equivalent  
 6 (1.00 FTE) Alzheimer's disease and related dementia services  
 7 coordinator position in the chronic disease prevention and  
 8 health promotion division of the department of health to promote  
 9 wellness and improve the quality and years of life for Hawaii's  
 10 people through effective prevention, detection, and management.

11 The sums appropriated shall be expended by the department  
 12 of health for the purposes of this Act.

13 SECTION 3. This Act shall take effect on July 1, 2019.
