A BILL FOR AN ACT

RELATING TO COMMUNITY MEETINGS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that informational
2 meetings and presentations open to the public provide the
3 opportunity for individuals who have an interest to attend and
4 learn more about the subject matter being discussed. However,
5 there is currently limited flexibility, pursuant to section
6 92-3.1, Hawaii Revised Statutes, that allows a county council
7 member to attend such meetings and presentations as an
8 individual with a similar private interest.

9 The purpose of this Act is to exempt members of a county
10 council from the limitation on the number of members that may
11 attend an informational meeting or presentation on matters
12 relating to official board business and clarifies that such
13 meetings for which two or more members of a board, but less than
14 a quorum, may attend shall be meetings that are open to the
15 public.

16 SECTION 2. Section 92-2.5, Hawaii Revised Statutes, is
17 amended by amending subsection (e) to read as follows:



1 "(e) Two or more members of a board, but less than the
2 number of members which would constitute a quorum for the board,
3 may attend an informational meeting or presentation on matters
4 relating to official board business, including a meeting of
5 another entity, legislative hearing, convention, seminar, or
6 community meeting; provided that the meeting or presentation is
7 open to the public and is not specifically and exclusively
8 organized for or directed toward members of the board. The
9 board members in attendance may participate in discussions,
10 including discussions among themselves; provided that the
11 discussions occur during and as part of the informational
12 meeting or presentation; and provided further that no commitment
13 relating to a vote on the matter is made or sought.

14 At the next duly noticed meeting of the board, the board
15 members shall report their attendance and the matters presented
16 and discussed that related to official board business at the
17 informational meeting or presentation.

18 Notwithstanding section 92-3.1, for purposes of this
19 subsection, the limitation on the number of members that may
20 attend an informational meeting or presentation shall not apply
21 to members of a county council."

2 SECTION 4. This Act shall take effect upon its approval.

Report Title:

Open Meetings; Sunshine Law; Permitted Interactions; County Councils

Description:

Exempts members of a county council from the limitation on the number of members that may attend an informational meeting or presentation on matters relating to official board business, including a meeting of another entity, legislative hearing, convention, seminar, or community meeting. Clarifies that such meetings shall be meetings that are open to the public for purposes of permitted interactions.
