
A BILL FOR AN ACT

RELATING TO THE DEPARTMENT OF LABOR AND INDUSTRIAL RELATIONS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. There is appropriated out of the general
2 revenues of the State of Hawaii the sum of \$2,565,469 or so much
3 thereof as may be necessary for fiscal year 2019-2020 and the
4 sum of \$1,772,998 or so much thereof as may be necessary for
5 fiscal year 2020-2021 for the disability compensation division
6 modernization project (LBR183/DA).

7 The sums appropriated shall be expended by the department
8 of labor and industrial relations for the purpose of this Act.

9 SECTION 2. There is appropriated out of the general
10 revenues of the State of Hawaii the sum of \$225,000 or so much
11 thereof as may be necessary for fiscal year 2019-2020 and the
12 same sum or so much thereof as may be necessary for fiscal year
13 2020-2021 for the independent verification and validation of the
14 disability compensation division modernization project
15 (LBR183/DA).

16 The sums appropriated shall be expended by the department
17 of labor and industrial relations for the purpose of this Act.



1 SECTION 3. There is appropriated out of the general
2 revenues of the State of Hawaii the sum of \$2,000,000 or so much
3 thereof as may be necessary for fiscal year 2019-2020 and
4 \$1,000,000 or so much thereof as may be necessary for fiscal
5 year 2020-2021 for the unemployment insurance modernization
6 project (LBR171/LA).

7 The sums appropriated shall be expended by the department
8 of labor and industrial relations for the purpose of this Act.

9 SECTION 4. There is appropriated out of the general
10 revenues of the State of Hawaii the sum of \$35,299 or so much
11 thereof as may be necessary for fiscal year 2019-2020 and the
12 sum of \$60,357 or so much thereof as may be necessary for fiscal
13 year 2020-2021 for one full-time equivalent (1.00 FTE) permanent
14 position for a disability compensation program specialist I
15 (LBR183/DA).

16 The sums appropriated shall be expended by the department
17 of labor and industrial relations for the purpose of this Act.

18 SECTION 5. There is appropriated out of the general
19 revenues of the State of Hawaii the sum of \$3,000,000 or so much
20 thereof as may be necessary for fiscal year 2020-2021 for



1 neighbor island staffing and IT support for the unemployment
2 insurance division (LBR171/LA).

3 The sum appropriated shall be expended by the department of
4 labor and industrial relations for the purpose of this Act.

5 SECTION 6. There is appropriated out of the general
6 revenues of the State of Hawaii the sum of \$200,000 or so much
7 thereof as may be necessary for fiscal year 2019-2020 and the
8 same sum or so much thereof as may be necessary for fiscal year
9 2020-2021 to be deposited into the labor law enforcement special
10 fund (ATG100).

11 SECTION 7. There is appropriated out of the labor law
12 enforcement special fund the sum of \$200,000 or so much thereof
13 as may be necessary for fiscal year 2019-2020 and the same sum
14 or so much thereof as may be necessary for fiscal year 2020-2021
15 for the purposes for which the fund is established (LBR902/AA).

16 The sums appropriated shall be expended by the department
17 of labor and industrial relations for the purposes of this Act.

18 SECTION 8. There is appropriated out of the general
19 revenues of the State of Hawaii the sum of \$42,500 or so much
20 thereof as may be necessary for fiscal year 2019-2020 and the
21 sum of \$85,000 or so much thereof as may be necessary for fiscal



1 year 2020-2021 for one full-time equivalent (1.00 FTE) permanent
2 staff attorney position for the labor and industrial relations
3 appeals board (LBR812/HA).

4 The sums appropriated shall be expended by the department
5 of labor and industrial relations for the purpose of this Act.

6 SECTION 9. There is appropriated out of the general
7 revenues of the State of Hawaii the sum of \$26,478 or so much
8 thereof as may be necessary for fiscal year 2019-2020 and the
9 sum of \$52,956 or so much thereof as may be necessary for fiscal
10 year 2020-2021 for one full-time equivalent (1.00 FTE) permanent
11 position for a program specialist IV for the Hawaii civil rights
12 commission (LBR153/RA).

13 The sums appropriated shall be expended by the department
14 of labor and industrial relations for the purpose of this Act.

15 SECTION 10. There is appropriated out of the general
16 revenues of the State of Hawaii the sum of \$34,758 or so much
17 thereof as may be necessary for fiscal year 2019-2020 and the
18 sum of \$59,236 or so much thereof as may be necessary for fiscal
19 year 2020-2021 for one full-time equivalent (1.00 FTE) permanent
20 labor law enforcement specialist IV position for the hearings
21 branch of the wage standards division (LBR152/CA).



1 The sums appropriated shall be expended by the department
2 of labor and industrial relations for the purpose of this Act.

3 SECTION 11. This Act shall take effect on July 1, 2050.
