SENATE CONCURRENT RESOLUTION

REQUESTING THE AUDITOR TO CONDUCT A PERFORMANCE AUDIT OF THE
DEPARTMENT OF LAND AND NATURAL RESOURCES' DIVISION OF
BOATING AND OCEAN RECREATION.

1 WHEREAS, the Department of Land and Natural Resources'
2 Division of Boating and Ocean Recreation (Division) manages the
3 State's small boat harbors, mooring and boating facilities, and
4 statewide ocean recreation programs; and
5

6 WHEREAS, the Division's responsibilities include enforcing
7 laws and rules pertaining to boating safety and regulation of
8 commercial activities, and overseeing permits for ocean
9 recreation events such as yacht races, canoe regattas, and
10 surfing contests; and
11

12 WHEREAS, in recent years, community members have expressed
13 numerous concerns about the Division, particularly its lack of
14 effective communication with the boating community, an
15 inconsistent approach to interpreting and enforcing
16 administrative rules, repeated and prolific complaints across
17 the State about division management, and ongoing issues of
18 employee misconduct complaints and ethics violations; and

20 WHEREAS, the Office of the Auditor previously conducted a
21 management audit of state boating facilities operations from
22 July 1, 1998, to June 30, 2000, and issued in April 2001 Report
23 No. 01-09, Audit of the Management of State Boating Facilities
24 by Department of Land and Natural Resources; and

26 WHEREAS, the report found that mismanagement of state
27 boating facilities has been a recurring problem, and recommended
28 that the Division develop strategic plans to address these
29 ongoing issues with the boating program; and

1 WHEREAS, it is in the public interest for the Auditor to
 2 conduct a performance audit of the current operations and
 3 management of the Division, considering the public's and the
 4 Auditor's long-standing concerns; now, therefore,
 5

6 BE IT RESOLVED by the Senate of the Thirtieth Legislature
 7 of the State of Hawaii, Regular Session of 2020, the House of
 8 Representatives concurring, that the Auditor is requested to
 9 conduct a performance audit of the operations and management of
 10 the Department of Land and Natural Resources' Division of
 11 Boating and Ocean Recreation; and
 12

13 BE IT FURTHER RESOLVED that the Auditor examine and include
 14 in its report whether the Division is using government resources
 15 in compliance with statutes, rules, and policies; whether the
 16 Division's activities are achieving their objectives; and
 17 whether those activities are being conducted effectively,
 18 efficiently, economically, ethically, and equitably; and
 19

20 BE IT FURTHER RESOLVED that the Auditor is requested to
 21 submit a report of any findings and recommendations, including
 22 any proposed legislation, to the Legislature no later than
 23 twenty days prior to the convening of the Regular Session of
 24 2022; and
 25

26 BE IT FURTHER RESOLVED that certified copies of this
 27 Concurrent Resolution be transmitted to the Auditor and the
 28 Chairperson of the Board of Land and Natural Resources.
