## SENATE RESOLUTION

URGING THE DEPARTMENT OF EDUCATION AND DEPARTMENT OF  
TRANSPORTATION SERVICES OF THE CITY AND COUNTY OF HONOLULU  
TO REMOVE THE BUS STOP LOCATED IN FRONT OF ILIMA  
INTERMEDIATE SCHOOL ON FORT WEAVER ROAD.

1 WHEREAS, more than eight hundred students attend and  
2 approximately one hundred faculty and staff members are employed  
3 by Ilima Intermediate School; and  
4

5 WHEREAS, bus stop number 1091 is located in front of Ilima  
6 Intermediate School on Fort Weaver Road; and  
7

8 WHEREAS, this bus stop is often the site of illegal  
9 activities, including illegal drug sales, public urination and  
10 defecation, and the illegal dumping of urine-filled bottles;  
11 used condoms, needles, and underwear; and packages containing  
12 drug paraphernalia, including crystal methamphetamine and  
13 marijuana paraphernalia; and  
14

15 WHEREAS, these activities endanger the health and safety of  
16 Ilima Intermediate School's students, faculty, and staff; and  
17 the neighboring community; and  
18

19 WHEREAS, these activities also cause significant delays to  
20 numerous residents who rely on The Bus as their primary mode of  
21 transportation; now, therefore,  
22

23 BE IT RESOLVED by the Senate of the Thirtieth Legislature  
24 of the State of Hawaii, Regular Session of 2020, that the  
25 Department of Education and the Department of Transportation  
26 Services of the City and County of Honolulu are urged to remove  
27 bus stop number 1091, located in front of Ilima Intermediate  
28 School on Fort Weaver Road; and

30 BE IT FURTHER RESOLVED that the Department of Education and  
31 the Department of Transportation services of the City and County  
32 of Honolulu are requested to notify those persons affected by



1 the removal of bus stop number 1091 that the following bus stops  
2 remain available for use:

4 (1) The Ewa Beach Transit Center, identified as bus stop  
5 number 4202; and

7 (2) The Fort Weaver Road and Makule Road bus stop,  
8 identified as bus stop number 1804; and

10 BE IT FURTHER RESOLVED that certified copies of this  
11 Resolution be transmitted to the Superintendent of Education and  
12 Director of the Department of Transportation Services of the  
13 City and County of Honolulu.
