begs leave to report as follows:


The purpose of this measure is to:

- (1) Require the Department of Health to adopt or amend rules to establish a classification system for composting facilities or operations for purposes of regulation; and
- (2) Allow composting and co-composting in the agricultural district, including on lands with class A or B soils.

Your Committee received testimony in support of this measure from the Hawaii Food Industry Association; Changing Tides Foundation; Kokua Hawaii Foundation; Zero Waste Oahu; Zero Waste Big Island; Community Compost Movement, North Shore; Kupaa Farms; Hawaii Youth Climate Coalition; Kanu Hawaii; Sustainable Coastlines Hawaii; and numerous individuals. Your Committee received comments on this measure from the Department of Health and City and County of Honolulu Office of Climate Change, Sustainability, and Resiliency.
