was referred H.B. No. 900, H.D. 1, entitled:

"A BILL FOR AN ACT RELATING TO VACCINATIONS,"

The purpose of this measure is to improve vaccination rates
in Hawaii by authorizing pharmacists, subject to prior
requirements, to administer any vaccines to minors between 11 and
17 years of age.

The Board of Pharmacy, Daniel K. Inouye College of Pharmacy
of the University of Hawai'i at Hilo, Hawai'i Immunization
Coalition, Walgreens Co., and a few concerned individuals
supported this measure. A concerned individual opposed this
measure. The Department of Health offered comments.

this report, your Committee is in accord with the intent and
purpose of H.B. No. 900, H.D. 1, and recommends that it be
referred to your Committee on Finance.
