- (2) Appropriate funds to continue the Pilot Programs, subject to certain conditions.

Your Committee received testimony in support of this measure from The Queen's Health Systems. Your Committee received comments on this measure from the Governor's Coordinator on Homelessness and Department of Human Services.

Your Committee has amended this measure by:

 Limiting the extension of the Pilot Programs to June 30, 2021, rather than December 31, 2021;


- (2) Deleting the appropriations for fiscal year 2020-2021 for the Pilot Programs;
- (3) Specifying that funds appropriated for the Pilot Programs pursuant to Act 209, Session Laws of Hawaii 2018, that were not expended or encumbered by June 30, 2019, shall lapse on June 30, 2021;
- (4) Making it effective retroactively to June 29, 2019; and
- (5) Making technical, nonsubstantive amendments for the purposes of clarity, consistency, and style.
