Your Committee on Higher Education, to which was referred
S.B. No. 318 entitled:

"A BILL FOR AN ACT MAKING AN APPROPRIATION TO THE UNIVERSITY
OF HAWAI'I AT HILO,"

begs leave to report as follows:

The purpose and intent of this measure is to appropriate
funds for three full-time equivalent (3.00 FTE) positions for the
custodial and maintenance staff at the University of Hawaii at
Hilo.

Your Committee received testimony in support of this measure
from the University of Hawai'i System and one individual.

Your Committee finds that over the last five years, the
University of Hawaii at Hilo campus has grown with the addition of
two new buildings and a third building, the Daniel K. Inouye
College of Pharmacy, scheduled to open in the summer of 2019.
These additional facilities require upkeep and maintenance to
interior and exterior spaces. This measure assists the University
of Hawaii at Hilo with maintaining facilities and grounds to
attract and retain students and employees who want to learn and
work in a twenty-first century environment.

As affirmed by the record of votes of the members of your
Committee on Higher Education that is attached to this report,
your Committee is in accord with the intent and purpose of S.B.



No. 318 and recommends that it pass Second Reading and be referred to your Committee on Ways and Means.
