Your Committee on Water and Land, to which was referred
S.C.R. No. 32 entitled:

"SENATE CONCURRENT RESOLUTION AUTHORIZING THE ISSUANCE OF A
TERM, NON-EXCLUSIVE EASEMENT COVERING A PORTION OF STATE
SUBMERGED LANDS AT NAPILI 2 AND 3, LAHAÏNA, MAUI, FOR AN
EXISTING WALKWAY, AND FOR USE, REPAIR, AND MAINTENANCE OF THE
EXISTING IMPROVEMENTS CONSTRUCTED THEREON,"

begs leave to report as follows:

The purpose and intent of this measure is to authorize the
issuance of a term, non-exclusive easement covering a portion of
state submerged lands fronting the property identified as Tax Map
Key: (2) 4-3-002:seaward of 026, 027, and 028, Napili 2 and 3,
Lahaina, Maui, for the existing walkway and for use, repair, and
maintenance of the existing improvements constructed thereon
pursuant to section 171-53, Hawaii Revised Statutes.

Your Committee received testimony in support of this measure
from the Department of Land and Natural Resources.

Your Committee finds that, pursuant to section 171-53, Hawaii
Revised Statutes, the Board of Land and Natural Resources may
lease submerged lands with the prior approval of the Governor and
the prior authorization of the Legislature by concurrent
resolution. Your Committee further finds that on June 28, 2019,
under agenda item D-7, the Board of Land and Natural Resources
approved the issuance of a separate term, non-exclusive easement



to run with the land and inure to the benefit of the abutting real property and to be coterminous with GL5998 to resolve the encroachment of the existing walkway identified in this measure. Your Committee concludes that the easement is necessary for the maintenance and repair of the existing walkway and for the use, repair, and maintenance of the existing improvements thereon.

As affirmed by the record of votes of the members of your Committee on Water and Land that is attached to this report, your Committee concurs with the intent and purpose of S.C.R. No. 32 and recommends its adoption.


