<a href="#"><u>SB 2301</u></a> <a href="#"><u>Status &amp; Testimony</u></a>	RELATING TO LITTER CONTROL. Establishes a cigarette litter abatement fee to be imposed on each cigarette sold in the State, the proceeds of which shall be deposited into a cigarette litter abatement special fund. Provides that the cigarette litter abatement special fund shall be used to cover the costs of collecting and removing cigarette litter and providing outreach and education to curb improper cigarette litter disposal. <a href="#"><u>SB 2503</u></a> <a href="#"><u>Status &amp; Testimony</u></a>	RELATING TO INDIVIDUAL WASTEWATER SYSTEMS. Establishes the time of transfer individual wastewater system inspection program to oversee the inspection and repair of any individual wastewater system at the time of the property's sale or transfer. Excludes certain sales or transfers.	AEN/CPH, JDC
<a href="#"><u>SB 2834</u></a> <a href="#"><u>Status &amp; Testimony</u></a>	RELATING TO HEMP. Establishes programs for the production and processing of hemp in Hawaii.	AEN/CPH, WAM/JDC
<a href="#"><u>SB 3106</u></a> <a href="#"><u>Status &amp; Testimony</u></a>	RELATING TO INDUSTRIAL HEMP. Requires DOA to establish a permanent hemp program pursuant to federal law, and a corresponding special fund. Requires DOH to adopt rules for the licensing, inspection, and regulation of industrial hemp processing facilities. Reduces or repeals certain regulatory provisions of existing hemp pilot program. Establishes authorized cultivation of hemp as affirmative defense. Excludes hemp from the definition of marijuana. Requires chairperson of board of agriculture to prepare a state plan for approval of the federal Secretary of Agriculture and report on the approval process to legislature and governor. Appropriates funds.	AEN/CPH, WAM/JDC
