RELATING TO BROADBAND SERVICE INFRASTRUCTURE.
Establishes the broadband infrastructure grant program within the Department of Business, Economic Development, and Tourism, to award grants to applicants to extend deployment of infrastructure used to provide broadband service to unserved and underserved areas of the State. Effective 7/1/2020. (SD2)


While every effort will be made to incorporate all testimony received, materials received on the day of the hearing or improperly identified or directed, may be distributed to the Committee after the hearing.
