<u>SB 3015</u> <u>Status & Testimony</u>	RELATING TO PROCUREMENT. Makes an appropriation to the department of accounting and general services for the purposes of funding training, development, and consulting services for innovative project delivery.	GVO, WAM
<u>SB 3085</u> <u>Status & Testimony</u>	RELATING TO SOCIALLY RESPONSIBLE INVESTING. Incorporates socially responsible investing in the investment decision-making of endowment, trust, or investment funds established by statute or maintained by state agencies or offices.	GVO, JDC/WAM
<u>SB 3100</u> <u>Status & Testimony</u>	RELATING TO SUSTAINABLE DEVELOPMENT GOALS. Codifies sustainable development goals based on the United Nations' Sustainable Development Goals and indicators.	GVO, WAM
<u>SB 3143</u> <u>Status & Testimony</u>	RELATING TO PROCUREMENT. Requires the state procurement office and the public works division of the department of accounting and general services to develop a ten-year pilot program to enable innovative methods of procurement. Establishes an exempt innovative project delivery coordinator position within the state procurement office. Makes an appropriation. Repeals 7/1/2030.	GVO, WAM
<u>SB 2452</u> <u>Status & Testimony</u>	RELATING TO GOVERNMENT PUBLICATIONS. Amends provisions relating to the distribution of government publications to require deposit of electronic or digital copies, unless printed copies are requested.	GVO, WAM
