<u>SB 2006</u> <u>Status & Testimony</u>	RELATING TO RANKED CHOICE VOTING. Establishes ranked choice voting for special federal elections and special elections of vacant county council seats.	JDC, WAM
<u>SB 2008</u> <u>Status & Testimony</u>	RELATING TO CIVIL LEGAL SERVICES. Appropriates funds for the judiciary to purchase civil legal services for low and moderate income persons.	JDC, WAM
<u>SB 3080</u> <u>Status & Testimony</u>	RELATING TO THE JUDICIARY. Appropriates supplemental funds for the Judiciary for the fiscal biennium beginning 7/1/2019, and ending 6/30/2021.	JDC, WAM
<u>SB 2148</u> <u>Status & Testimony</u>	RELATING TO VIOLATIONS OF CAMPAIGN FINANCE LAW. Increases the amount of the fine that may be assessed against a noncandidate committee making only independent expenditures that has received at least one contribution of more than \$10,000, or spent more than \$10,000 in an election period, for campaign spending law violations. Allows the Campaign Spending Commission to order that payment of a fine assessed against a noncandidate committee, or any portion thereof, be paid from the personal funds of an officer of the noncandidate committee. <u>SB 2179</u> <u>Status & Testimony</u>	RELATING TO THE DEPARTMENT OF THE PROSECUTING ATTORNEY. Appropriates funds as a grant-in-aid to the Department of the Prosecuting Attorney for the City and County of Honolulu for the Career Criminal Prosecution Unit.	JDC, WAM

<u>SB 2619</u> <u>Status & Testimony</u>	MAKING AN APPROPRIATION TO THE OFFICE OF THE PROSECUTING ATTORNEY FOR HAWAII COUNTY. Appropriates funds as a subsidy to the office of the prosecuting attorney for Hawaii county for the career criminal prosecution unit.	JDC, WAM
<u>SB 2186</u> <u>Status & Testimony</u>	PROPOSING AMENDMENTS TO ARTICLE V OF THE CONSTITUTION OF THE STATE OF HAWAII TO AUTHORIZE LEGISLATION REGARDING THE PROCESS BY WHICH CRIMINAL REPRIEVES, COMMUTATIONS, AND PARDONS ARE SUBMITTED TO AND CONSIDERED BY THE GOVERNOR. Proposes amendments to the Constitution of the State of Hawaii relating to the authorization of legislation governing the process by which executive reprieves, commutations, and pardons are submitted to and considered by the governor. <u>SB 2241</u> <u>Status & Testimony</u>	RELATING TO INTOXICATING LIQUOR. Requires that a class 10 special license be issued for the sale and consumption of liquor in an outdoor premise only within a beer garden. Defines beer garden.	JDC
<u>SB 2844</u> <u>Status & Testimony</u>	MAKING APPROPRIATIONS FOR CLAIMS AGAINST THE STATE, ITS OFFICERS, OR ITS EMPLOYEES. Makes appropriations for claims against the State, its officers, and its employees.	JDC, WAM
<u>SB 2361</u> <u>Status & Testimony</u>	RELATING TO MARIJUANA DECRIMINALIZATION. Repeals criminal prohibitions and penalties pertaining to marijuana.	JDC, WAM
