Status

RELATING TO HELPING WORKING FAMILIES.
Makes the state earned income tax credit refundable and permanent.
Increases and amends the refundable food/excise tax credit by basing
the amount of the credit on a taxpayer's Hawaii earned income, rather
than federal adjusted gross income. Increases minimum wage rate to
\$11.00 per hour beginning on 1/1/2021, \$12.00 per hour beginning on
1/1/2022, \$12.50 per hour beginning on 1/1/2023, and \$13.00 per hour
beginning on 1/1/2024.


As this is a decision making meeting only, no public testimony will be accepted.


