<u>HB 1955</u> <u>Status</u>	RELATING TO ELECTRIC FOOT SCOOTERS. Establishes a framework for the regulation of electric foot scooters by the State and counties. Amends definitions of "moped" to exclude electric foot scooters.	TRN, JUD
<u>HB 1617</u> <u>Status</u>	RELATING TO DRIVER'S LICENSES. Changes the renewal period for driver's licenses for persons 72 years old or older from every two years to every four years.	TRN, JUD
<u>HB 1812</u> <u>Status</u>	RELATING TO HIGHWAY SAFETY. Specifies that the driver's license of a civilian employee or civilian contractor of the United States Department of Defense that expires while the employee or contractor is stationed outside the United States remains valid for ninety days after the employee or contractor returns to the United States.	TRN, JUD
<u>HB 1813</u> <u>Status</u>	RELATING TO HIGHWAY SAFETY. Authorizes the examiner of drivers to accept driver's license renewal applications from civilian employees and contractors of the federal Department of Defense more than six months prior to the date of expiration under certain conditions.	TRN, JUD
<u>HB 1992</u> <u>Status</u>	RELATING TO TRANSPORTATION. Requires depth gauge signs to be posted on any portion of a public highway that lies within a special flood hazard area and is prone to flooding. Appropriates funds.	TRN, FIN
<u>HB 2152</u> <u>Status</u>	RELATING TO TRAFFIC VIOLATIONS. Requires additional circumstances under which every vehicle, including motor vehicles, motorcycles, motor scooters, and motorized bicycles, moving on any public highway in the State must display its lighted head lamps.	TRN, JUD



<u>HB 2355</u> <u>Status</u>	RELATING TO BOATING REPORTS. Requires the fire chief and the ocean safety director of each county, in addition to the Director of Public Safety and the police chief of each county, to transmit to the Department of Land and Natural Resources a copy of every report relating to boating accidents or the theft, loss, or recovery of vessels. Requires all reports submitted pursuant to section 200-27, Hawaii Revised Statutes, to be unredacted.	TRN, FIN
<u>HB 1930</u> <u>Status</u>	RELATING TO TAXATION. Increases the amount of the rental motor vehicle surcharge tax from \$5 to \$8.	TRN, FIN
<u>HB 1990, HD1</u> <u>(HSCR73-20)</u> <u>Status</u>	RELATING TO TAXATION. Permanently directs specified percentages of the general excise tax revenues to a new educational infrastructure special fund for the department of education and other entities responsible for school facilities to augment its capacity and infrastructure and to the department of transportation to protect the state highway system from the threat of inundation and damage caused by climate change. Directs specified percentages of revenues from a new, temporary state improvement surcharge to the foregoing purposes and to certain state funds. Takes effect on 7/1/2050. (HD1)	LHE, TRN, FIN
<u>HB 1973</u> <u>Status</u>	RELATING TO NON-GENERAL FUNDS. Abolishes, repeals, or reclassifies various non-general funds of the Department of Transportation.	TRN, FIN
<u>HB 2475</u> <u>Status</u>	RELATING TO CARGO CARRIERS. Authorizes the Department of Transportation to expend funds from the harbor special fund to provide subsidies to cargo carriers to offset costs incurred by the cargo carriers as a result of providing cargo carrier services to ports serving counties within the State having a population of less than 500,000 and comprising three or more populated islands. Appropriates moneys.	TRN, FIN

DECISION MAKING TO FOLLOW


