Makes permanent insurance requirements for transportation network companies and transportation network drivers. Effective 7/1/2050. (HD2)</p>	<p>TRS, CPH/WAM</p>
<p><a href="#">HB 2750, HD2</a> <a href="#">(HSCR987-20)</a> <a href="#">Status &amp; Testimony</a></p>	<p>RELATING TO MONETARY OBLIGATIONS. Prohibits the imposition of restrictions on a person's ability to obtain or renew a driver's license or to register, renew the registration of, or transfer or receive title to a motor vehicle, as a consequence of unpaid monetary obligations under certain circumstances. Allows certain individuals to petition the court for a driver's license or motor vehicle clearance. Effective July 1, 2050. (HD2)</p>	<p>TRS, JDC</p>
