Thank you for the opportunity to provide written testimony on behalf of the Department of Defense which supports HB 1334, Relating to the Department of Defense Operating Budget which appropriates funds for the Department of Defense's Executive Branch Fiscal Biennium 2019-22; however, we request reconsideration for the following item stated below.

Item 6. (DEF Item 36.) Major Disaster Fund. Hawaii had 2 presidentially declared disasters in FY 2018, April 2018 Severe Storms and May 2018 Kilauea East Rift Zone. This request is to provide funds for a Major Disaster in the State of Hawaii. If funds are unused, the funds would expire and go back to the general fund.
