**Title of Bill:** HB 2049 RELATING TO HEALTH.

**Purpose of Bill:** Directs public school teachers to confiscate electronic cigarettes or electronic cigarette products. Requires public schools to coordinate with the appropriate county police departments for the proper disposal of confiscated electronic cigarettes or electronic cigarette products.

**Department's Position:**

The Department of Education (Department) appreciates the intent and offers concerns on HB 2049.

The Department's highest priority is the safety and well-being of students. As such, the Department is working in partnership with the Hawaii Department of Health (DOH) to educate youth to make positive decisions about their health.

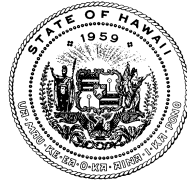
There is a zero tolerance policy for tobacco products and electronic smoking devices (ESDs) on the Department's campuses, transportation, and/or during Department school-sponsored activities. In accordance with Section 712-2156, Hawaii Revised Statutes, any tobacco product(s) or ESDs found in a student's possession is a violation of Chapter 19, shall be seized by school administration and forfeited to law enforcement.

The Department of Health has recently categorized ESDs as acute hazardous waste. This new classification of ESDs has caused concern for the Department as it pertains specifically to the health and safety of students, faculty, and staff. It is imperative that the confiscated ESDs be removed on a schedule that is consistent and timely (within three months).

Thank you for the opportunity to provide testimony on HB 2049.

1 **Department Testimony:** The Department of Health (DOH) offers comments on House Bill 2049  
2 (H.B. 2049). Current law (Chapter 712-1258(6), Hawaii Revised Statutes) provides for seizure,  
3 forfeiture, and confiscation by the State with required disposal by law enforcement without funding.

4 Waste nicotine products, including electronic cigarettes, are considered acutely toxic  
5 hazardous waste under the state's regulations and schools would be considered the "generator" of  
6 the hazardous waste when disposing of electronic cigarettes confiscated from students. Electronic  
7 cigarettes are also hazardous because of the lithium batteries they contain.

8 Existing regulations for hazardous waste disposal (Chapters 11-260.1 to 11-279.1, Hawaii  
9 Administrative Rules) require hazardous waste to be sent to a permitted hazardous waste treatment,  
10 storage, or disposal facility (TSDF), unless the generator is a Very Small Quantity Generator  
11 (VSQG). There are no commercial TSDFs in the state. The waste will need to be transported to the  
12 U.S. mainland by a specialized hazardous waste transportation contractor. If the school is a VSQG,  
13 its hazardous waste can be managed at a permitted municipal solid waste facility.

14 Police departments are likewise not set up to properly dispose of hazardous wastes and  
15 would only take electronic cigarettes from schools if they are evidence in an administrative or  
16 judicial proceeding, they do not become a waste until the evidence is released at the conclusion of  
17 the proceeding.

Chair Mizuno, Chair Woodson, and Members of the Joint Committee:

The Hawaii Primary Care Association (HPCA) is a 501(c)(3) organization established to advocate for, expand access to, and sustain high quality care through the statewide network of Community Health Centers throughout the State of Hawaii. The HPCA **SUPPORTS** House Bill No. 2049, RELATING TO HEALTH.

The bill, as received by your Committee, would:

- (1) Require a teacher or educator at a public school to confiscate an electronic cigarette or electronic cigarette product if it is found in the possession of a student under the age of twenty-one;
- (2) Require each public school to coordinate with the applicable county police department for the proper disposal of confiscated electronic cigarettes or electronic cigarette products; and
- (3) Provides immunity to any teacher or educator for any act or failure to act in accordance with the foregoing.

By way of background, the HPCA represents Hawaii Federally-Qualified Health Centers (FQHCs). FQHCs provide desperately needed medical services at the frontlines in rural and underserved communities. Long considered champions for creating a more sustainable, integrated, and wellness-oriented system of health, FQHCs provide a more efficient, more effective and more comprehensive system of healthcare.

FQHCs have long seen first-hand how tobacco has literally destroyed the lives of our patients and their families. Because of the ubiquity of cigarettes, chewing tobacco, and now electronic smoking devices, the impacts of tobacco affect our citizenry on a generational basis with people experimenting at even earlier ages.

The Coalition for a Tobacco-Free Hawai'i, a program of the Hawai'i Public Health Institute<sup>i</sup> provides **Comments on HB 2049**, which would direct teachers to confiscate tobacco products and coordinate with county policies departments for disposal.

### **The Coalition recommends consideration of other measures to decrease youth use of tobacco products.**

Instead of placing the burden on our public-school educators, the focus should be on passing laws that are known to be effective at reducing tobacco use. Confiscation and disposal will not solve our youth vaping epidemic and will place high cost and burden on the Department of Education for disposal of these hazardous materials. The health of our children needs to be protected at all costs, in and out of the classroom. When children are not in school, it is unclear what the enforcement will be. Rather than focus on punitive laws, we must hold the industry responsible. Vaping products must be regulated and treated in the same way as tobacco products and to counter the tobacco industry's targeted marketing to kids.

The Centers for Disease Control and Prevention outlines a number of proven strategies to prevent youth tobacco use, none of which include penalizing youth for possession or using tobacco products. Recommended efforts include: regulating tobacco products; decreased access to tobacco products; increased price of tobacco

products; tobacco prevention policies and programs in schools; and increased enforcement of restrictions on tobacco sales to minors.

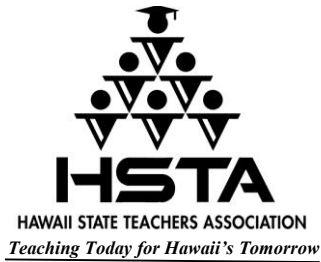

The Hawaii State Teachers Association **opposes HB 2049** which directs public school teachers to confiscate electronic cigarettes or electronic cigarette products and requires public schools to coordinate with the appropriate county police departments for the proper disposal of confiscated electronic cigarettes or electronic cigarette products.

While we appreciate the intent of this measure, asking public school teachers to confiscate electronic smoking devices and products is not a solution to the youth vaping epidemic. The confiscation of these products is extremely difficult because they have to be visible before a teacher can attempt to confiscate the product. Furthermore, if a teacher witnesses a student vaping but the student has hidden the product, the teacher is unable to confiscate it. Additionally, requiring teachers to handle and or store e-liquids which is a hazardous material is problematic.

Confiscating e-cigarettes or e-cigarette products from students is not an effective strategy to reduce usage among our youth. Conversely, **increasing regulation and taxation on these products so that they are more difficult for our youth to obtain and as well as banning the use of flavors other than tobacco is a proven strategy for the reduction of usage among children.** For these reasons, we respectfully **oppose HB 2049.**
