Aloha Chair Johanson, Vice Chair Eli and Members of the Committee,

The Āliamanu-Salt Lake-Foster Village Neighborhood Board No.18 has been concerned with the development of the Aloha Stadium parcel due to its proximity to our neighborhood. The Board has continuously been involved in the masterplan process of the New Aloha Stadium Entertainment District and receives updates from the State of Hawaii Department of Accounting and General Services and the Stadium Authority.

This measure calls for the addition of two members to the Stadium Authority placing an appointment restriction that the individuals be residents of two defined communities as set forth in the bill. The intent of the bill to add these two members to the Stadium Authority to ensure the community is involved in the process is great. The recommendation to the Committee would be to amend the bill to require members be from the Aiea Neighborhood Board area and the Āliamanu-Salt Lake-Foster Village Neighborhood Board area to guarantee provide more specific language for the Governor to consider all residents who live in the neighboring community.

This item will be added on the February 13, 2020 agenda to provide the Board to take official action on the items. Thank you for opportunity to provide comments on this measure.
