Chair, Vice Chair, and Members,

I support this legislation with a HUGE caveat.

I support the legislation only in that no one should face any penalties for not registering a firearm, *at all*, much less for doing so after the state-demanded date.

I find it extremely ironic that with this bill the legislature is essentially providing people the opportunity for them to infringe upon their own constitutionally-protected right to keep arms by reporting themselves to the government for not reporting themselves to the government, in a purported timely manner, which has already infringed their rights by criminalizing them for exercising their rights and not reporting it to the government!

That's so twisted! But expected here in Hawaii where anything having to do with the pre-existing natural unalienable God-given fundamental individual enumerated constitutionally-protected civil rights regarding self-defense are treated not only with disdain, but with criminalization.

One can only hope that Justice Kavanaugh's words re the unconstitutionality of registration of firearms comes home to roost in Hawaii in the near future, the sooner the better. As Judge Kavanaugh, prior to his confirmation as Justice of the Supreme Court of the United States, sitting as judge in the United States Court of Appeals for the District of Columbia, issued a dissent in *Heller v District of Columbia* (*Heller II*, 2011) where he discusses the question of registration of firearms and writes "Today, most states require no registration for any firearms; only seven states require registration for some firearms; and **only Hawaii requires registration for all firearms.**" He then goes on (pp.2-3)(emphasis added):

D.C.'s *registration requirement... is likewise unconstitutional.* Heller and later McDonald said that regulations on the sale, possession, or use of guns are permissible if they are within the class of traditional, "longstanding" gun regulations in the United States. Registration of all lawfully possessed guns – as distinct from licensing of gun owners or mandatory recordkeeping by gun sellers – has not traditionally been

required in the United States and even today remains highly unusual. Under Heller's history- and tradition-based test, D.C.'s **registration requirement is therefore unconstitutional.**

The legislature can save us all a lot of time and expense, not to mention the great embarrassment that will ensue after all the Hawaii government bureaucrats at all levels declare that no, registration *is* constitutional (just as they now do regarding the ban on electric guns, despite the 2015 unanimous *per curiam* issued by SCOTUS in Caetano to the contrary), and to prove it they will take the case all the way to the Supreme Court, at which time Justice Kavanaugh and his full-and-complete-Bill-of-Rights-respecting fellow Justices will likely declare Hawaii's law(s) unconstitutional.

Here's my real suggestion: Gut and replace this bill with a total repeal of any demand by the state that those exercising their rights must report any such exercise thereof to the State.

That proposed legislation would, for a start, look like this:

~~§134-3 Registration, mandatory, exceptions. (a) Every person arriving in the State who brings or by any other manner causes to be brought into the State a firearm of any description, whether usable or unusable, serviceable or unserviceable, modern or antique, shall register the firearm within five days after arrival of the person or of the firearm, whichever arrives later, with the chief of police of the county of the person's place of business or, if there is no place of business, the person's residence or, if there is neither a place of business nor residence, the person's place of sojourn. A nonresident alien may bring firearms not otherwise prohibited by law into the State for a continuous period not to exceed ninety days, provided that the person meets the registration requirement of this section and the person possesses:~~

~~—(1) A valid Hawaii hunting license procured under chapter 183D, part II, or a commercial or private shooting preserve permit issued pursuant to section 183D-34;~~

~~—(2) A written document indicating the person has been invited to the State to shoot on private land;~~
~~or~~

~~—(3) Written notification from a firing range or target shooting business indicating that the person will actually engage in target shooting.~~

~~The nonresident alien shall be limited to a nontransferable registration of not more than ten firearms for the purpose of the above activities.~~

~~—Every person registering a firearm under this subsection shall be fingerprinted and photographed by the police department of the county of registration, provided that this requirement shall be waived where fingerprints and photographs are already on file with the police department. The police department shall perform an inquiry on the person by using the International Justice and Public Safety Network, including the United States Immigration and Customs Enforcement query, the National Crime Information Center, and the National Instant Criminal Background Check System, pursuant to section 846-2.7 before any determination to register a firearm is made.~~

~~—(b) Every person who acquires a firearm pursuant to section 134-2 shall register the firearm in the manner prescribed by this section within five days of acquisition. The registration shall be on forms prescribed by the attorney general, which shall be uniform throughout the State, and shall include the following information: name of the manufacturer and importer; model; type of action; caliber or gauge; serial number; and source from which receipt was obtained, including the name and address of the prior registrant. If the firearm has no serial number, the permit number shall be entered in the space provided for the serial number, and the permit number shall be engraved upon the receiver portion of the firearm prior to registration. All registration data that would identify the individual registering the firearm by name or address shall be confidential and shall not be disclosed to anyone, except as may be required:~~

~~—(1) For processing the registration;~~

~~—(2) For database management by the Hawaii criminal justice data center;~~

~~—(3) By a law enforcement agency for the lawful performance of its duties; or~~

~~—(4) By order of a court.~~

~~—(c) Dealers licensed under section 134-31 or dealers licensed by the United States Department of Justice shall register firearms pursuant to this section on registration forms prescribed by the attorney general and shall not be required to have the firearms physically inspected by the chief of police at the time of registration.~~

~~—(d) Registration shall not be required for:~~

~~—(1) Any device that is designed to fire loose black powder or that is a firearm manufactured before 1899;~~

~~—(2) Any device not designed to fire or made incapable of being readily restored to a firing condition; or~~

~~—(3) All unserviceable firearms and destructive devices registered with the Bureau of Alcohol, Tobacco, and Firearms of the United States Department of Justice pursuant to Title 27, Code of Federal Regulations.~~

~~—(e) No fee shall be charged for the registration of a firearm under this section, except for a fee chargeable by and payable to the registering county for persons registering a firearm under subsection (a), in an amount equal to the fee charged by the Hawaii criminal justice data center pursuant to section 846-2.7. In the case of a joint registration, the fee provided for in this section may be charged to each person. RE: SB1321 SD1 Relating to Firearms

Aloha Members of the Senate Committee,

The Hawaii Firearms Coalition SUPPORTS SB1321 SD1 with amendments.

The Hawaii Firearms Coalition finds that Hawaii's HRS 134-3 (relating to firearms registration) is harmful to firearm owners and unnecessary and therefore should be repealed. However we support SB1321 because it's even worse to make criminals out of good people that want to do the right thing by registering their firearms even if late.

Hawaii's firearms permitting and registration process is overly complex with short deadlines, such as the requirement in HRS 134-3 to register a firearm within 5 days of acquisition or entering the state else receive a petty misdemeanor. Law abiding citizens sometimes cannot meet these deadlines due to reasons such as:

1. Life problems – Busy work schedules, family emergencies, etc.
2. Military training and unexpected work projects
3. Not knowing registration is required (registration is not required in most states)
4. Inheriting a firearm and finding it years later

Another example is that the 5 day registration requirement doesn't exclude weekends and holidays. If a person acquires their firearm on Friday night (day 1), holds it for the weekend (day 2,3), and Monday is a holiday (day 4) then they have only 1 day to register it since firearms registration is closed on nights, weekends, holidays, and is only available in one location on Oahu. A very tough requirement to meet for a person working two jobs due to Hawaii's high cost of living. Hawaii's firearm permitting and registration is an overburdened process to the average working person so it's understandable why people may register firearms late.

Please amend the bill by deleting "provided that the duty to register the firearm shall be an ongoing duty" and "including any ongoing duty to register pursuant to this section," as it's unnecessary and may

imply re-registration of firearms is required. This language was deleted last year in SB1036 SD2 by the Senate Judiciary committee for those reasons as can be seen in SSCR570 which is attached.

For these reasons the Hawaii Firearms Coalition Supports SB1321 SD1. Thank you for your consideration.

Your Committee on Judiciary and Labor, to which was referred S.B. No. 1036, S.D. 1, entitled:

"A BILL FOR AN ACT RELATING TO FIREARMS,"

begs leave to report as follows:

The purpose and intent of this measure is to:

- (1) Clarify that the failure to register a firearm within the required time period does not relieve the owner of the duty to register the firearm; and
- (2) Allow the owner of an unregistered firearm to register the firearm thereafter without penalty.

Your Committee received testimony in support of this measure from the Police Department, City and County of Honolulu; Lessons In Firearms Education; and two individuals.

Your Committee finds that existing law lacks sufficient clarity regarding the duties of firearms owners to register their firearms even after the deadline to register has passed. To ensure that all firearms are properly registered, this measure encourages owners to properly register their firearms and allows law enforcement agencies to maintain more accurate records of firearms within the State.

Your Committee has amended this measure by:

- (1) Deleting language that specifies that the duty to register a firearm is an ongoing one;

- (2) Inserting an effective date of January 7, 2059, to encourage further discussion; and

- (3) Making technical, nonsubstantive amendments for the purposes of clarity and consistency.

As affirmed by the record of votes of the members of your Committee on Judiciary and Labor that is attached to this report, your Committee is in accord with the intent and purpose of S.B. No. 1036, S.D. 1, as amended herein, and recommends that it pass Third Reading in the form attached hereto as S.B. No. 1036, S.D. 2.
