Testimony in SUPPORT of S.B. 2431
RELATING TO EMERGENCY MEDICAL SERVICES

1 **Fiscal Implications:** This bill appropriates funds for DOH to conduct comprehensive
2 workforce and cost analysis reviews with federal partners to improve the efficiency, quality,
3 and cost effectiveness. Appropriates funds for collective bargaining increases and other
4 current expenses to maintain current Emergency Medical Services (EMS) system. The
5 measure appropriates:

- 6 1. \$25,000 for the workforce study;
- 7 2. \$100,000 for comprehensive cost analysis to improve the efficiency, quality, and cost
8 effectiveness of Hawaii's Statewide EMS program;
- 9 3. \$15,776,780 for collective bargaining; and
- 10 4. \$3,997,494 for other current expenses.

11 **Department Testimony:** The Department of Health supports S.B. 2431. ACT 60 (2019)
12 Legislature required a comprehensive review of the Hawaii Ems System. From October 14-18,
13 2019 the National Highway Transportation Safety Administration (NHTSA) conducted a re-
14 assessment of the State EMS System. The positive report made multiple recommendations to
15 improve the system. This bill addresses three (3) recommendations: 1) Conduct a comprehensive

1 Statewide workforce study reviewing the entire EMS System, the status of the workforce and
2 identify any gaps by county 2) Conduct a comprehensive cost analysis of the entire EMS System.
3 Based on this analysis revise the system to include looking at identification of centralized
4 purchasing and other possible cost-saving measures, and 3) Establish a sustainable source of
5 funding for the EMS and trauma system.

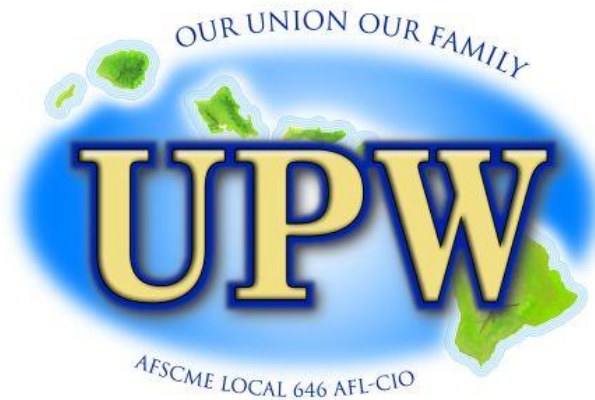
6 S.B. 2431 allocates the sum of \$25,000 to fund the workforce study. The results will be used to
7 describe Hawaii's pre-hospital workforce providing invaluable information for training priorities
8 and to ensure an adequate supply of care providers.

9 Recommendations two (2) and three (3) fit together. A sustainable, funded EMS system is
10 required for this essential service for residents and visitors. The comprehensive cost analysis
11 study is necessary to understand funding requirements and answer continuing questions about
12 system cost. S.B. 2431 allocates the sum of \$100,000 for the study.

13 In 2019, the legislature appropriated funds for three new ambulance units for Kauai, Hawaii, and
14 City and County of Honolulu. Funding was renewed for FY 2020. S.B.2431 continues funding
15 for FY 2021 as part of other current expenses (OCE) in the sum of \$3,997,494. S.B.2431 also
16 funds FY 2021 collective bargaining (CB) requirements at \$15,776,780.

17 Passage of S.B.2431 is critical to continue Hawaii's current level of EMS care. If the funds are
18 not provided for collective bargaining increases and other current expenses, a reduction in
19 personnel and services would be necessary to remain within funding limits:

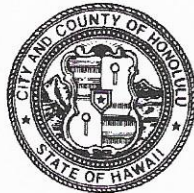
