In consideration of SENATE BILL 3011, SENATE DRAFT 1 RELATING TO THE STATE OF HAWAII MUSEUM OF MONARCHY HISTORY

Senate Bill 3011, Senate Draft 1 proposes to appropriate funds for the purposes of restoration, repair, maintenance, operation, and one full-time equivalent (1.0 FTE) groundskeeper for 'Iolani Palace. The Department of Land and Natural Resources (Department) strongly supports this measure provided that its passage does not replace or adversely impact priorities indicated in the Executive Supplemental Budget.

The Department has executed a 25-year general lease with the Friends of 'Iolani Palace (FOIP) to manage and operate 'Iolani Palace, 'Iolani Palace Barracks (Hale Koa) and the Coronation Pavilion. FOIP is authorized to host events via special use permits to generate funding to support the management and maintenance costs of this unique and significant historic and cultural feature.

As with other state park units across the State, 'Iolani Palace has been subject to years of deferred maintenance and inadequate reinvestment and operational support. The FOIP has done a magnificent job of stewardship and providing programs with the limited resources at their disposal based on fees and donations. It is difficult to prioritize the list of deferred maintenance projects that are critically needed at 'Iolani Palace. However, this current list in the measure, if fully funded, will provide both the assurance of the physical integrity of many of the historical structural elements and improve the experience to the palace patrons in the years to come. Given the unique value as one of our most esteemed cultural assets, it is a moral imperative to redirect funds for the sustainability of 'Iolani Palace.

The Department supports \$2,335,000 in general funds for the repair, restoration, and maintenance of 'Iolani Palace which includes \$100,000 in general funds for a structural survey, an electrical survey and a five- to ten-year working plan for 'Iolani Palace and \$250,000 for

The Department of Budget and Finance (B&F) offers comments on Senate Bill (S.B.) No. 3011, S.D. 1.

S.B. No. 3011, S.D. 1, appropriates funds for the restoration, repair, operation, and maintenance of Iolani Palace and designates the Department of Land and Natural Resources (DLNR) as the expending agency of the appropriation.

Page 2, lines 10-13 of the bill, specifies that appropriated funds shall be in addition to and not supplant any portion of the base budget of B&F for the State of Hawai'i Museum of Monarchy History (the official designation of the Friends of Iolani Palace pursuant to Chapter 6E-35, HRS). B&F would like to point out that although the department has an ongoing general fund subsidy for Bishop Museum, the department does not provide any support for Iolani Palace.


