Dear Senators,

Young Progressives Demanding Action (YPDA) advocates for public policies that reflect the values of young people throughout the State of Hawai'i. One of those values is that democracy works when the act of seeking a profit is not at the cost of our community. YPDA is in **support** of **SB3046**.

As the Giffords Law Center points out, "Researchers estimate that nationwide, approximately 2,000 firearms dealers and pawnbrokers knowingly sell firearms illegally, engaging in behavior including failing to keep required records, transferring to prohibited persons, making false entries in record books, and conducting illegal out-of-state transfers."¹

This bill would close the loophole in which gun sellers who illegally sell firearms to persons who are not qualified to own firearms would result in them having to go to court, but the firearm seller could be able to continue to do business in Hawai'i. Hawai'i is lauded for its strong gun laws, but we can always do more to make our communities safer for our keiki.
