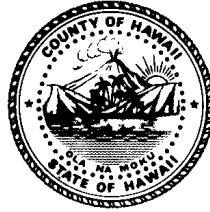

Dear Chair Rhoads, Vice Chair Keohokalole, and Committee Members:

RE: SB 2519, SD1 Relating to Firearms
SB 2635, SD1 Relating to Firearms Ammunition
SB 3054, SD1 Relating to Firearm Registration

The First Amendment to the Constitution of the United States provides for freedom of religion, speech, and press; and the right to peaceably assemble and to petition the government. Yet, as fundamental and sacrosanct as those values are to America, few if any would argue that those freedoms are not subject to reasonable restrictions (take the cliché of “yelling ‘Fire’ in a crowded theater”).

Similarly, the Second Amendment guarantees the right to keep and bear arms. This right, too, must be subject to reasonable restrictions, or else we would each be able to have our own machine gun mounted on our mantelpiece or strapped over our shoulders.

So the question comes down to what is reasonable. That should be determined by a free people acting through their elected representatives, in this case our State Legislature. And given the times in which we live, and the carnage that we have witnessed both in our own state and across the country, I thank you for taking on the divisive but crucial task of deciding what reasonable restrictions might be.

You have three bills on today's agenda that would impinge on the right to keep and bear arms:

SB 2519, SD1 would prohibit large capacity magazines for all firearms. Such magazines are already restricted for pistols, and SB 2519, SD1 might be the most important bill before you today, given the data on mass shootings that is set forth in the preamble of the bill.

SB 2635, SD1 would regulate ammunition the same way firearms are regulated and require the licensing of sellers of ammunition. It would seem that this proposal would be particularly valuable in the case of a firearm that is lost or stolen, but also in tracing ammunition that is used in a crime.

S B3054, SD1 would require notification when a firearm is moved out-of-state. This would be of some value, though perhaps limited. On the other hand, the burden on a gun owner seems minimal.

Can any of the restrictions contained in the three bills be considered unreasonable? I have no doubt that some will say yes, but I would argue that all of these bills would make Hawai'i a safer place, without unduly restricting the right to keep and bear arms.

Again, thank you for taking on these issues.

Honorable Chair Rhoads, Honorable Vice Chair Keohokalole and Members of the Committee

The Kaua'i Police Department (KPD) **opposes**, Senate Bill 3054 SD1, which requires the registration of firearms that are moved out of the State.

It would be nearly impossible to enforce this law given the fact that the firearms were moved out of state and the probability that the owner moved as well. Criminal penalties for failure to report the removal of firearms from the State would go unenforced as extradition back to Hawaii to face criminal charges is unlikely. An unenforceable law nullifies its purpose.

Further, the KPD does not have the resources to register firearms that are moved out of State. Presently, the KPD has one firearms clerk responsible for the registration of all firearms within the County of Kauai. With no funding attached to this Bill, this is essentially an unfunded mandate that would cause a financial and logistical hardship on our organization.

For these reasons the Kauai Police Department **opposes**, Senate Bill 3054 SD1.

SB3054 is another example of a bill that will do nothing to make it safer in Hawaii. The current data is already not accurate to begin with. Firearms sold to another person may still be on the original persons list of registered firearms. Please oppose SB3054. This bill unfairly burdens people that are moving out-of-state. Largely, the military segment of Hawaii's population. I urge you to OPPOSE this Bill as it accomplishes nothing. It has no affect on crime, does not affect public safety or serve any lawful purpose. It also oversteps the States authority as the State would not have any legal jurisdiction over any person or item that is not within the State boundaries or legal enclave. How would the State prosecute this offense? By what mechanism would it be enforced?

How would said firearm be removed from the roles of registered firearms in the State of Hawaii? How would the record be destroyed as the State would have no legal purview over the firearm? How would the owner of the firearm be notified that the removal is complete? In most instances, the firearms have left the state with the owner. Is the owner duty bound to return to Hawaii to "unregister" the firearms as the firearms must be registered while they are in the State. Who is responsible for the costs incurred to travel back to Hawaii?

If the firearms are transferred via sale, there is already a mechanism under HRS 134-2 and 134-4. Even the firearms are sold to an out of state buyer they go through the transfer process via an FFL and completing the chain of custody for registration.

By creating another burdensome layer, the only thing accomplished by this revised statute would be creating "victimless crimes" and creating a "solution" to a problem that does not exist.

I urge you to OPPOSE SB3054.

It also oversteps the States authority as the State would not have any legal jurisdiction over any person or item that is not within the State boundaries or legal enclave. How would the State prosecute this offense? By what mechanism would it be enforced?

How would said firearm be removed from the roles of registered firearms in the State of Hawaii? Would the record of registration be destroyed as the State would have no legal purview over the firearm? How would the owner of the firearm be notified that the removal is complete? In most instances, the firearms have left the state with the owner. Is the owner duty bound to return to Hawaii to “unregister” the firearms as the firearms must be registered while they are in the State. Who is responsible for the costs incurred to travel back to Hawaii?

If the firearms are transferred via sale, there is already a mechanism under HRS 134-2 and 134-4. Even the firearms are sold to an out of state buyer they go through the transfer process via an FFL and completing the chain of custody for registration.

By creating another burdensome layer, the only thing accomplished by this revised statute would be creating “victimless crimes” and creating a “solution” to a problem that does not exist.

The proposal to over regulate and require special licenses to purchase ammunition is also burdensome and unnecessary due to the fact that many people reload their own ammunition at home with special tools. Most all of these people are law abiding and most ammunition purchases are by law abiding owners. So again the criminals will steal or otherwise attain ammunition outside of any regulatory structure that is developed.

Banning certain calibers of firearms is also rather ludicrous when one realizes that certain black powder and flintlock rifles carry heavy projectiles in .50 caliber and larger based on the historical or historical replica barrels and projectiles used. The Civil War mini-ball. (Mine'i) is in made and sold calibers of .50 and above depending upon the type of historical rifle.

Additionally: Concealed Carry Weapon permits (CCW) are void here even though the MacDonal and Heller decisions in the Supreme Court uphold the individual righty to carry a firearm for personal protection. Every state that allows personal concealed carry has had reductions in violent crime and it has repeatedly been shown that restrictions against the law abiding have little, if any effect on crime. There may be more firearms than people in this state and our low violent crime rates do not support added regulations that will only affect the law abiding firearms community.

Please stand up for the 2nd amendment and protect our rights as law abiding individuals to keep and bear arms. We are not the problem here.
