Dear Chair Nishihara and Members:

SUBJECT: Senate Bill No. 621, Relating to Firearms

I am David Nilsen, Acting Major of the Records and Identification Division of the Honolulu Police Department (HPD), City and County of Honolulu.

The HPD supports Senate Bill No. 621, Relating to Firearms.

We believe that a change is needed to ensure that firearms that are lost, stolen or destroyed are reported to the appropriate law enforcement agencies. Law enforcement, having knowledge of these missing firearms, will then be able to enter this information into national and local databases, disseminating their status to the widest possible audience.

The HPD is requesting that one change be made to this bill. We recommend that the time allowed for the surrender of firearms upon a third offense be stated in Hawaii Revised Statutes (HRS) Section d (2) as being seven days. This will bring this bill in agreement with the provisions of HRS 134-7.3 (b), which allows seven days for the surrender of firearms upon disqualification of ownership and possession.



The new section should read, "Surrender all firearms and ammunition to the chief of police of the appropriate county within seven days of disqualification; and..."

Re: **Senate Bill 621 – OPPOSE**

Dear Chairman Nishihara:

On behalf of the Hawaii members of the National Rifle Association, we oppose Senate Bill 621.

SB 621 would place firearms owners in jeopardy of criminal prosecution for failure to report lost, stolen or destroyed firearms within 24 hours.

Firearm owners voluntarily and regularly report stolen firearms to the appropriate authorities. However, the criminal penalties associated with SB 621 could turn victims of loss into criminals and compromise cooperation with law enforcement. A firearms owner who was unaware of the legal requirement to report the loss, theft or destruction of a firearm and who is contacted by police investigating a crime faces possible criminal prosecution for failing to report that the firearm was stolen or missing. Such an owner will need to hire a lawyer, who will advise them to remain silent while immunity is negotiated, rather than quickly supplying police the information they need to properly and promptly investigate the crime, which may be time sensitive.

For the foregoing reasons, we urge your opposition to SB 621.

SB 621 is another one-size-fits-none bill that further victimizes gun owners who are the victims of crime to report the loss of their firearm or suffer the consequences. This is typical of the legislation we have seen lately – a “guilty before proven innocent” approach to lawful firearms ownership. I surmise this is to prevent firearms from ending up in the hands of criminals – but this bill targets citizens who may be victims of crime or simple misfortune. This is wrong headed. If the senate was serious about gun crime – it should add additional penalties and fines for those who used an illegally acquired or un-registered firearm in the commission of a crime. Instead this bill appears to be an attempt to discourage firearms ownership through penalizing its loss.
