A BILL FOR AN ACT

MAKING EMERGENCY APPROPRIATIONS TO THE DEPARTMENT OF PUBLIC SAFETY RELATING TO COVID-19 EXPENDITURES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. This Act is recommended by the governor for
- 2 immediate passage in accordance with article VII, section 9, of
- 3 the Constitution of the State of Hawaii.
- 4 SECTION 2. The legislature finds that the impact of the
- 5 SARS-CoV-2 virus and resulting coronavirus disease 2019
- 6 (COVID-19) pandemic has been devastating to global, national,
- 7 and state economies.
- 8 The Coronavirus Aid, Relief, and Economic Security Act
- 9 (CARES Act), Public Law 116-136, was enacted on March 27, 2020,
- 10 to address the extensive health and economic fallout of the
- 11 COVID-19 pandemic and provided federal funds to support the
- 12 State's COVID-19 relief efforts. With the expiration of federal
- 13 CARES Act funds, the legislature finds that additional funds are
- 14 needed to continue funding critical COVID-19 response programs
- 15 and activities for the remainder of fiscal year 2020-2021.

- 1 Accordingly, the purpose of this Act is to appropriate
- 2 funds for COVID-19 response activities and provide transparency
- 3 and accountability for the use of those funds.
- 4 SECTION 3. There is appropriated out of the general
- 5 revenues of the State of Hawaii the sum of \$2,106,460 or so much
- 6 thereof as may be necessary for fiscal year 2020-2021 for
- 7 healthcare professional costs and inmate hospitalization
- 8 expenses at non-state facilities for Hawaii inmates.
- **9** The sum appropriated shall be expended by the department of
- 10 public safety for the purposes of this Act.
- 11 SECTION 4. There is appropriated out of the general
- 12 revenues of the State of Hawaii the sum of \$1,100,000 or so much
- 13 thereof as may be necessary for fiscal year 2020-2021 for
- 14 providing food services and deep cleaning, disinfecting, and
- 15 sanitizing departmental offices and correctional facilities.
- The sum appropriated shall be expended by the department
- 17 public safety for the purposes of this Act.
- 18 SECTION 5. There is appropriated out of the general
- 19 revenues of the State of Hawaii the sum of \$136,201 or so much
- 20 thereof as may be necessary for fiscal year 2020-2021 for
- 21 security costs, overtime, and other payroll costs for

- 1 ten existing full-time equivalent (10.00 FTE) deputy sheriff
- 2 positions to continue security screening and protocols for the
- 3 safe travels Hawaii program.
- 4 The sum appropriated shall be expended by the department of
- 5 public safety for the purposes of this Act.
- **6** SECTION 6. The governor is authorized to transfer funds
- 7 appropriated by this Act among all executive agencies as deemed
- 8 necessary; provided that the governor is authorized to transfer
- 9 funds in excess of what is needed for the department of public
- 10 safety to the governor's contingency fund as deemed necessary by
- 11 the governor for the purposes of this Act.
- 12 SECTION 7. The appropriations made by this Act shall not
- 13 lapse at the end of the fiscal year for which the appropriations
- 14 are made; provided that all moneys from the appropriation
- 15 unencumbered as of June 30, 2022, shall lapse as of that date.
- SECTION 8. This Act shall take effect upon its approval.
