# A BILL FOR AN ACT

RELATING TO THE CONFERENCE CENTER REVOLVING FUND.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Section 304A-2272, Hawaii Revised Statutes, is
amended to read as follows:

3 "[<del>[</del>]\$304A-2272[<del>]</del>] Conference center revolving fund; 4 University of Hawaii at Hilo. (a) There is established the 5 conference center revolving fund for [the] conference center 6 [program in the college of continuing education and community 7 service of programs conducted by the University of Hawaii at 8 Hilo. All fees, charges, and other moneys collected in 9 conjunction with [the] conference center [program] programs 10 shall be deposited in the revolving fund. The [dean of the 11 college of continuing education and community service] 12 chancellor of the University of Hawaii at Hilo or the 13 chancellor's designee is authorized to expend funds from the 14 revolving fund for all costs associated with [conducting] 15 conferences, seminars, and courses provided by [the] conference 16 center [program,] programs, including but not limited to 17 expenses for honoraria, hotel and room rentals, food and 18 refreshment, printing and mailing, airfare and per diem, [leis,] 2021-2710 SB1222 CD1 SMA.doc

2	and materials [-], without regard to any competitive bidding
3	requirements pursuant to chapter 103D.
4	(b) The chancellor of the University of Hawaii at Hilo
5	shall submit a report to the legislature no later than twenty
6	days prior to the convening of each regular session that
7	includes an accounting for all income and expenditures of the
8	revolving fund under this section."
9	SECTION 2. Statutory material to be repealed is bracketed
10	and stricken. New statutory material is underscored.
11	SECTION 3. This Act shall take effect upon its approval.
