A BILL FOR AN ACT

RELATING TO VESSELS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that vessel ownership and

2 operation come with many responsibilities and that vessels

3 likewise pose significant threats to natural resources and to

4 public health and safety if abandoned, neglected, or left in

5 disrepair. The legislature recognizes that unauthorized,

6 abandoned, grounded, and derelict vessels on state property and

7 in the waters of the State must be removed as soon as possible

8 to minimize the hazards posed to the public while balancing the

9 vessel owner's right to due process.

Since 2002, the division of boating and ocean recreation

within the department of land and natural resources has expended

in excess of \$2,340,000 from the boating special fund to address

unauthorized, abandoned, grounded, and derelict vessels on state

property or in the waters of the State. However, under existing

15 law, in many instances, by the time the department of land and

16 natural resources may begin removing an unauthorized, abandoned,

grounded, or derelict vessel, the condition of the vessel has

18 deteriorated, further complicating removal efforts and



- 1 increasing the potential to create threats to public health,
- 2 public safety, and natural resources.
- 3 The purpose of this Act is to amend provisions regarding
- 4 the designation, impoundment, and disposal of unauthorized,
- 5 abandoned, grounded, and derelict vessels on state property or
- 6 in the waters of the State to facilitate faster responses of
- 7 these proceedings.
- 8 SECTION 2. Section 200-16, Hawaii Revised Statutes, is
- 9 amended to read as follows:
- 10 "§200-16 [Mooring of unauthorized vessel in state small
- 11 boat harbors and offshore mooring areas; Unauthorized vessels;
- 12 impoundment and disposal proceedings. (a) [No person shall
- 13 moor a vessel in a state small boat harbor or offshore mooring
- 14 area without obtaining a use permit; nor shall a person continue
- 15 to moor a vessel in any state small boat harbor or offshore
- 16 mooring area if the use permit authorizing the vessel to moor
- 17 has expired or otherwise been terminated.] A vessel moored
- 18 without a valid use permit or moored with a use permit that has
- 19 expired or been terminated [is] shall be deemed an unauthorized
- 20 vessel [and is subject to] in violation of this section[-] and
- 21 shall be subject to impoundment and disposal.

1	(b) The department shall [cause to be placed] place upon,
2	or as near to [the] an unauthorized vessel as possible, a notice
3	to remove the vessel, which shall, at a minimum, indicate that
4	the vessel is in violation of this section, the date and time
5	the notice was posted, and that the vessel [must] shall be
6	removed within seventy-two hours [from] of the time that the
7	notice was posted[-]; provided that if the vessel is in imminent
8	danger of breaking up on state submerged land, a shoreline, or a
9	coral reef, the notice shall indicate that the owner shall
10	commence effective salvage operations within twenty-four hours
11	of the time that the notice was posted.
12	(c) An unauthorized vessel may be impounded by the
13	department at the sole risk and expense of the owner of the
14	$vessel[_{\mathcal{T}}]$ if the vessel is not removed after the
15	[seventy-two-hour] period [or] specified in subsection (b).
16	Calculation of the time period shall not restart if, during that
17	period, the vessel is [removed and remoored in the harbor or
18	mooring or anchorage area or any other state harbor or mooring
19	or anchorage area without a use permit.] moved anywhere in the
20	waters of the State or to any public property and remains in
21	violation of this section. The owner of the vessel shall be

- 1 solely responsible for all costs of the impoundment and the
- 2 disposal of the unauthorized vessel. All owners of unauthorized
- 3 vessels that are impounded by the department shall be
- 4 responsible for paying impound storage fees to the department
- 5 while the vessel remains impounded and until the time that the
- 6 vessel is returned to the custody of a person entitled to
- 7 possession. Impound storage fees shall be equal to the rate set
- 8 by the department for vessels moored without a valid permit.
- 9 Any proceeds [resulting from] collected by the department in
- 10 relation to the impoundment and the disposal of the unauthorized
- 11 vessel shall be used first to pay for the costs of impoundment
- 12 and disposal [and], then to pay for any additional costs related
- 13 to the impoundment and disposal, then to pay for any outstanding
- 14 mooring fees due[-] to the department from the owner, and then
- 15 to the general fund. If the proceeds resulting from the
- 16 impoundment and the disposal are inadequate to pay for all costs
- 17 and mooring fees due, the owner of the unauthorized vessel shall
- 18 remain liable for [the] paying the department any and all
- 19 outstanding costs and mooring fees [-] due.
- 20 (d) Custody of an unauthorized vessel shall be returned to
- 21 the person entitled to possession only upon payment [to the

- 1 department] in full of all fees and costs due $[\tau]$ to the
- 2 department and any and all fines levied by the department or a
- 3 court[-] of competent jurisdiction. In addition, the
- 4 department, within seventy-two hours of impoundment, shall send
- 5 by certified mail, return receipt requested, a notice of
- 6 impoundment to the registered or documented owner or any lien
- 7 holder or operator of the impounded vessel on record with the
- 8 department or the United States Coast Guard. The owner, lien
- 9 holder, or operator of the impounded vessel shall have [ten]
- 10 five working days after receipt of notice of impoundment of the
- 11 vessel to request [in writing] an administrative hearing.
- 12 [This] A request for an administrative hearing [is] under this
- 13 subsection shall:
- 14 (1) Be made in writing to the department;
- 15 (2) Not be deemed delivered until the time that the
- department receives the written request; and
- 17 (3) Be solely for the purpose of allowing the owner, lien
- holder, or operator of an impounded vessel to contest
- the basis given by the department for the impoundment
- of the vessel.

- 1 The administrative hearing [must] shall be held within five
- 2 working days of [the department's receipt] delivery of the
- 3 written request. The department [shall] may adopt rules
- 4 pursuant to chapter 91 to implement the requirement for this
- 5 post-seizure administrative hearing process.
- 6 (e) Any unauthorized vessel impounded under this section[7
- 7 which] that remains unclaimed for more than [thirty] ten working
- 8 days by the registered or documented owner, a lien holder, or
- 9 operator of record $[\tau]$ may be sold by the department at public
- 10 auction. If the department does not, or is unable to, sell the
- 11 vessel at public auction, [or if its appraised value is less
- 12 than \$5,000 as determined by an independent appraiser with at
- 13 least one year of experience in the sale and purchase of
- 14 vessels, the department, after giving public notice of intended
- 15 disposition, if that notice was not previously included in a
- 16 public auction notice, may sell the vessel by negotiation,
- 17 retain and use the vessel, donate [it] the vessel to any other
- 18 government agency, or dispose of [it] the vessel as junk."
- 19 SECTION 3. Section 200-41, Hawaii Revised Statutes, is
- 20 amended to read as follows:

- 10 imprisoned not more than thirty days, or both, for each offense.
- 11 Each day of each violation shall be deemed a separate offense.
- 12 All criminal fines collected pursuant to this subsection shall
- 13 be deposited into the general fund in accordance with
- 14 section 706-643. It shall be an affirmative defense to
- 15 prosecution that a vessel was abandoned during a national
- 16 emergency declared by the President or Congress of the United
- 17 States, or a state of emergency declared by the governor, or as
- 18 otherwise approved in writing by the chairperson, or the
- 19 chairperson's designee; provided that the defense shall be valid
- 20 only for the duration of the declared emergency or written
- 21 approval."

1 SECTION 4. Section 200-42, Hawaii Revised Statutes, is 2 amended to read as follows: 3 "\$200-42 Notice to owner. (a) A state or county agency, 4 upon taking custody of any vessel[7] deemed abandoned pursuant 5 to section 200-41, shall immediately post a written notice on 6 the vessel and send a duplicate original by registered or certified mail, with a return receipt requested, to any owner 7 8 registered with the department or documented by the United 9 States Coast Guard or any lien holder or operator of the vessel 10 on record with the department or the United States Coast Guard 11 at their respective last known address on record with the 12 department or the United States Coast Guard. The notice shall 13 contain a brief description of the vessel, the location of 14 custody, and the intended disposition of the vessel if not 15 repossessed within [twenty] ten working days after the mailing 16 of the notice. [Such owner, lien holder, or operator, of the 17 vessel shall have ten days after receipt of the mailed notice to 18 request in writing an administrative hearing pursuant to 19 chapter 91 from the state or county agency that took custody of 20 the vessel. This administrative hearing is solely for the 21 purpose of allowing the owner, lien holder, or operator of an

11	owner, lien holder, or operator of record for more than ten
12	working days after mailing of the notice required by
13	section 200-42 may be sold at public auction by the state or
14	county agency that took custody of the vessel. If the agency
15	does not, or is unable to, sell the vessel at public auction,
16	the agency, after giving public notice of intended disposition,
17	may sell the vessel by negotiation, retain and use the vessel,
18	donate the vessel to any other government agency, or dispose of
19	the vessel as junk."
20	SECTION 6. Section 200-47.5, Hawaii Revised Statutes, is
21	amended by amending subsections (b) to (g) to read as follows:

- 12 writing to the department, shall not be deemed delivered until
- 13 the time that the department receives the written request, and
- 14 shall be solely for the purpose of allowing the owner, lien
- 15 holder, or operator of [an] the impounded vessel to contest the
- 16 basis given by the department for the impoundment of the vessel.

- 18 working days of [the department's receipt] delivery of the

- the notice, whichever occurs later, the vessel may be disposed 1 2 of by negotiated sale except that, when two or more purchasers indicate an interest in purchasing the vessel, the vessel [will] 3 shall be sold at public auction to the highest bidder[, unless 4 the vessel is exempt from public auction under section 200-45]. 5 If no purchaser expresses a desire to purchase the vessel, the 6 7 vessel may be destroyed or donated to any governmental agency." SECTION 8. Section 200-45, Hawaii Revised Statutes, is 8 9 repealed. 10 ["\$200-45 When public auction not required. Public
 - ["\$200-45 When public auction not required. Public auction shall not be required when the appraised value of any vessel is less than \$5,000, as determined by an independent appraiser who has at least one year of experience in the sale or purchase of vessels. Upon that determination, after public notice of intended disposition has been given at least once, the state or county agency that took custody of the vessel may sell the vessel by negotiation, dispose of it as junk, or donate the vessel to any governmental agency."]
- 19 SECTION 9. Statutory material to be repealed is bracketed 20 and stricken. New statutory material is underscored.
- 21 SECTION 10. This Act shall take effect upon its approval.
