The United Public Workers and the employer have reached agreements concerning collective bargaining (CB) for Units 1 and 10. Notification of ratification of the CB agreements was issued on April 22, 2021. The only cost items are for Employer-Union Trust Fund contributions. In accordance with Section 89-10(b), cost items must be submitted to the Legislature for appropriation. The following summary of the included and excluded requirements of the settlement for the current fiscal biennium are being transmitted to the Legislature for authorization:
