Dear Senate President Kouchi and Speaker Saiki:

The University of Hawai'i Professional Assembly and the employer have reached an agreement concerning collective bargaining (CB) for Unit 7. Notification of ratification of the CB agreement was issued on April 22, 2021. The only cost items are for Employer-Union Trust Fund contributions. In accordance with Section 89-10(b), cost items must be submitted to the Legislature for appropriation. The following summary of the included and excluded requirements of the settlement for the current fiscal biennium are being transmitted to the Legislature for authorization:

A BILL FOR AN ACT

RELATING TO PUBLIC EMPLOYMENT COST ITEMS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

PART I

SECTION 1. There is appropriated from the source of funding indicated below to health premium payments (BUF 761) the following sums or so much thereof as may be necessary to fund for fiscal biennium 2021-2023 the Hawaii employer-union health benefits trust fund costs in the agreement negotiated with the exclusive bargaining representative of collective bargaining unit (7):

	<u>FY 2021-2022</u>	<u>FY 2022-2023</u>
General funds	\$755,252	\$3,207,701

SECTION 2. Funds appropriated by this part shall be allotted by the director of finance to the appropriate state departments for expenditure in the respective fiscal year for the purposes of this part.

PART II

SECTION 3. There is appropriated from the source of funding indicated below to health premium payments (BUF 761) the

following sums or so much thereof as may be necessary to fund
 for fiscal biennium 2021-2023 the Hawaii employer-union health
 benefits trust fund costs authorized by chapter 89C, Hawaii
 Revised Statutes, for state officers and employees who are
 excluded from collective bargaining unit (7):

General funds	\$34,140	\$139,633

SECTION 4. Funds appropriated by this part shall be
 allotted by the director of finance to the appropriate state
 departments for expenditure in the respective fiscal year for
 the purposes of this part.

PART III

SECTION 5. Salary increases and cost adjustments provided
 in this Act for any officer or employee whose compensation is
 paid, in whole or in part, from federal, special, or other funds
 shall be paid wholly or proportionately, as the case may be,
 from the respective funds.

SECTION 6. Funds appropriated or authorized by this Act
 that are not expended or encumbered by June 30, 2022, and
 June 30, 2023, of the respective fiscal years, shall lapse as of
 those dates.

1 SECTION 7. This Act, upon its approval, shall take effect
2 on July 1, 2021.
