A BILL FOR AN ACT

RELATING TO LAY NETS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Despite detailed lay net rules implemented by 2 the department of land and natural resources (department), 3 including lay net registration and identification requirements 4 and restrictions on lay net dimensions, mesh size, soak time, 5 time of day, frequency between sets, water depth, and location, 6 the illegal and irresponsible use of lay nets continues with 7 adverse impacts to both fishery resources and protected species. 8 Furthermore, lay net violations are primary fishery-related 9 infractions that the department investigates, and that a lay net permit system is necessary to better regulate this gear type. 10 11 The purpose of this Act is to authorize the department to 12 adopt rules to establish a lay net permit for the use or 13 possession of lay nets, including reasonable permit fees and provisions for revocation, suspension, and withholding of 14 15 permits for non-compliance with lay net rules. 16 SECTION 2. Section 187A-5, Hawaii Revised Statutes, is 17 amended to read as follows:

JUSTIFICATION: Despite detailed lay net rules implemented

by the Department, including lay net

registration and identification requirements and restrictions on lay net dimensions, mesh size, soak time, time of day, frequency between sets, water depth, and location, the illegal and irresponsible use of lay nets continues with adverse impacts to both

fishery resources and protected species.

Lay net violations are primary fisheryrelated infractions that the Department investigates. A lay net permit system is necessary to better regulate this gear type.

Impact on the public: Lay net fishers would be required to obtain a permit from the Department. The general public would not be impacted but would benefit from improvements to the management of marine resources.

Impact on the Department and other agencies:

A lay net permit would enhance the Department's ability to enforce lay net rules by allowing the Department to revoke,

suspend, or withhold a permit for non-

compliance.
