A BILL FOR AN ACT

RELATING TO A NONRESIDENT RECREATIONAL MARINE FISHING LICENSE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Fishing in marine waters is an important
2	pastime for the people of Hawaii, providing valuable
3	opportunities for outdoor recreation, subsistence, and
4	transmission of cultural practices and values. Hawaii's marine
5	fishing opportunities also attract thousands of visitors each
6	year, from professional anglers who come to participate in big
7	game fishing tournaments to weekend fishing enthusiasts seeking
8	to enjoy their favorite recreational activity while on vacation.
9	With ever increasing pressure on the State's marine resources,
10	it is critical that the State identify and develop sustainable
11	sources of funding to effectively manage its fisheries.
12	Furthermore, the department of land and natural resources
13	(department) issues commercial marine fishing licenses and
14	freshwater game fishing licenses. License fees are used toward
15	management of commercial marine fisheries and recreational
16	freshwater fisheries. Additionally, Hawaii residents pay taxes
17	that support state fisheries management programs. In contrast,
18	nonresident recreational fishers directly benefit from enjoyment

1 of Hawaii's marine fishery resources without directly 2 contributing to management of those resources. A nonresident recreational marine license and associated fees would provide an 3 4 additional source of revenue to the State for marine fisheries 5 management. Fees would be deposited into the department's sport 6 fish special fund in accordance with section 187A-9.5, Hawaii 7 Revised Statutes. 8 The purposes of this Act are to: 9 (1) Establish a nonresident recreational marine fishing 10 license requirement and fees to enable the department 11 to more effectively manage the marine fisheries 12 resources of the State; and 13 (2) Require the department to adopt rules to implement 14 this license. SECTION 2. Chapter 188, Hawaii Revised Statutes, is 15 16 amended by adding a new section to be appropriately designated 17 and to read as follows: 18 "§188- Nonresident recreational marine fishing license; 19 application; fees; restrictions. (a) It is unlawful for any 20 nonresident of the State of Hawaii, except children below 21 fifteen years of age and members of the armed forces of the 22 United States on active duty in the State and their spouse and

1 minor children, to fish for, take, or catch any marine life for 2 noncommercial or recreational purposes without first obtaining a 3 nonresident recreational marine fishing license. The department 4 shall adopt rules pursuant to chapter 91 necessary for the 5 purposes of this section. 6 Nonresident recreational marine fishing licenses shall (b) 7 be issued by agents of the department upon written application 8 in such form as may be prescribed by the department together 9 with payment of a fee. The fee for a nonresident recreational 10 marine fishing license shall be as follows: 11 One-day fishing license = (1)\$20 12 (2) Seven-day fishing license = \$40 13 (3) Annual fishing license = \$70 14 Fees established by this subsection may be increased by the 15 department not more frequently than once every five years, at 16 the rate of the consumer price index change from July 2021, 17 compounded annually, rounded to the nearest dollar. 18 (c) No person to whom a license has been issued under this section shall permit any other person to carry, display, or use 19 20 the license for any purpose. Every person to whom a license has 21 been issued under this section shall show the license upon

3	(d) It shall be illegal to sell or offer for sale any			
4	marine life taken under a nonresident recreational marine			
5	fishing license, provided that marine life taken by nonresident			
6	licensees on board a charter fishing vessel owned or operated by			
7	a person with a valid commercial marine license pursuant to			
8	section 189-2(b), may be sold.			
9	(e) The department may revoke any nonresident recreational			
10	marine fishing license for any violation of the terms and			
11	conditions of the license. Any person whose nonresident			
12	recreational marine fishing license has been revoked shall not			
13	be eligible to apply for another nonresident recreational marine			
14	fishing license until expiration of one year from the date of			
15	revocation.			
16	(f) For the purposes of this section:			
17	(1) "Marine life" has the same meaning as defined in			
18	section 187A-1;			
19	(2) "Nonresident" means any individual who is not a			
20	resident of Hawaii as defined in this section; and			
21	(3) "Resident of Hawaii" means an individual who has:

4		immediately prior to applying for, or obtaining a
5		license or permit;
6	<u>(B)</u>	Filed or paid the individual's State of Hawaii
7		income taxes for the previous tax period; or
8	<u>(C)</u>	Established the individual's domicile in the
9		State of Hawaii, as evidenced by documentation
10		showing the individual's address, such as a valid
11		State of Hawaii driver's license, a valid State
12		of Hawaii identification card, a valid State of
13		Hawaii school identification card, or any other
14		official document issued to the individual within
15		the last thirty days from a government agency,
16		financial institution, insurance company, or
17		utility company.
18	(g) Any	person violating this section or any rule adopted
19	pursuant to th	is section shall be subject to administrative
20	penalties as p	rovided by section 187A-12.5."
