## A BILL FOR AN ACT

RELATING TO A NONRESIDENT RECREATIONAL MARINE FISHING LICENSE.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:


1 SECTION 1. The legislature finds that fishing in marine 2 waters is an important pastime for the people of Hawaii, 3 providing valuable opportunities for outdoor recreation, subsistence, and transmission of cultural practices and values. 4 5 Hawaii's marine fishing opportunities also attract thousands of 6 visitors each year, from professional anglers who participate in 7 big game fishing tournaments to weekend fishing enthusiasts 8 seeking to enjoy their favorite recreational activity while on 9 vacation. With ever increasing pressure on the State's marine 10 resources, it is critical that the State identify and develop 11 sustainable sources of funding to effectively manage its 12 fisheries.

13 The legislature further finds that the department of land 14 and natural resources issues commercial marine fishing licenses 15 and freshwater game fishing licenses. The department uses these 16 license fees toward management of commercial marine fisheries 17 and recreational freshwater fisheries. Additionally, Hawaii

residents pay taxes that support state fisheries management
 programs. In contrast, nonresident recreational fishers
 directly benefit from enjoyment of Hawaii's marine fishery
 resources without directly contributing to management of those
 resources.

6 The legislature also finds that a nonresident recreational
7 marine license and associated fees would provide an additional
8 source of revenue to the State for marine fishery management.
9 Fees would be deposited into the department's sport fish special
10 fund pursuant to section 187A-9.5, Hawaii Revised Statutes.


11 The purpose of this Act is to:

12 (1) Establish a nonresident recreational marine fishing
13 license requirement and fees to enable the department
14 of land and natural resources to more effectively
15 manage the marine fishery resources of the State; and
16 (2) Require the department of land and natural resources
17 to adopt rules to implement this license.

18 SECTION 2. Chapter 188, Hawaii Revised Statutes, is
19 amended by adding a new section to be appropriately designated
20 and to read as follows:

1	" <u>§188-</u> Nonresident recreational marine fishing license;
2	application; fees; restrictions. (a) It shall be unlawful for
3	any nonresident of the State who has attained the age of
4	fifteen, except members of the armed forces of the United States
5	on active duty in the State and their spouse and minor children,
6	to fish for, take, or catch any marine life for noncommercial or
7	recreational purposes without first obtaining a nonresident
8	recreational marine fishing license. The department shall adopt
9	rules pursuant to chapter 91 necessary for the purposes of this
10	section.
11	(b) Nonresident recreational marine fishing licenses shall
12	be issued by agents of the department upon written application
13	in a form prescribed by the department and upon payment of a
14	fee. The fees for a nonresident recreational marine fishing
15	license shall be as follows:
16	(1) For a one-day fishing license - \$20;
17	(2) For a seven-day fishing license - \$40; and
18	(3) For an annual fishing license - \$70.
19	Fees established by this subsection may be increased by the
20	department no more frequently than once every five years, at the






1	rate of the consumer price index change from July 2021,
2	compounded annually, rounded to the nearest dollar.
3	(c) No person to whom a license has been issued under this
4	section shall permit any other person to carry, display, or use
5	the license for any purpose. Each person to whom a license has
6	been issued under this section shall show the license upon
7	demand of any officer authorized to enforce the fishing laws of
8	the State.
9	(d) It shall be illegal to sell or offer for sale any
10	marine life taken under a nonresident recreational marine
11	fishing license; provided that marine life taken by nonresident
12	licensees on board a charter fishing vessel owned or operated by
13	a person with a valid commercial marine license pursuant to
14	section 189-2(b) may be sold.
15	(e) The department may revoke any nonresident recreational
16	marine fishing license for any violation of the terms and
17	conditions of the license. Any person whose nonresident
18	recreational marine fishing license has been revoked shall not
19	be eligible to apply for another nonresident recreational marine
20	fishing license until one year after the date of revocation.




