### A BILL FOR AN ACT

RELATING TO THE AQUATIC LIFE AND WILDLIFE ADVISORY COMMITTEES.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. 1 The legislature finds that the coronavirus 2 (COVID-19) pandemic has had a catastrophic impact on the world 3 economy. The complexities of dealing with a worldwide health 4 crisis have added additional layers of uncertainty that may increase the time needed for recovery. As a result of this, the 5 6 State has initiated a fiscal biennium 2021-2023 program review to identify ways to: 7

- 8 (1) Reduce expenditures;
- 9 (2) Identify programs, functions, and activities for
- 10 possible elimination that, although well-intentioned,
- 11 are of marginal benefit, low-performing, or of lesser 12 priority; and
- 13 (3) Identify cost-saving opportunities in core and primary
  14 programs and services through tightening program
  15 eligibility, reducing program benefits, improving
  16 efficiency, or cost shifting.

1 The legislature further finds that the department of land 2 and natural resources (department), after thorough review and 3 much scrutiny, has determined that the aquatic life and wildlife 4 advisory committees have rarely convened or been needed, and as 5 such, are outdated. While this Act would reduce the size of the 6 animal species advisory commission by removing the chairs of the 7 aquatic life and wildlife advisory committees from the animal 8 species advisory commission, the department believes that there 9 is still sufficient representation on the animal species 10 advisory commission to carry out its duties. The department is 11 also able to administratively convene a like advisory committee 12 if it deems necessary. 13 The purpose of this Act is to repeal the aquatic life and 14 wildlife advisory committees and make conforming amendments. 15 SECTION 2. Section 197-1, Hawaii Revised Statutes, is 16 amended by repealing the definition of "committee". 17 [""Committee" means the aquatic life and wildlife advisory 18 committee established in each of the counties of the State."] 19 SECTION 3. Section 197-2, Hawaii Revised Statutes, is

1 "(a) There is established within the department an animal 2 species advisory commission which may serve in an advisory 3 capacity to the board. The commission shall consist of 4 [thirteen] nine members to be appointed by the governor in the 5 manner provided in section 26-34. [The chairperson of each 6 aquatic life and wildlife advisory committee established 7 pursuant to this chapter and three] Three members of the 8 department designated by the chairperson of the department, and 9 no less than one each from the professional fields of aquatic 10 life, wildlife, and conservation and resources enforcement, 11 shall serve as members of the commission. Six of the members 12 shall be scientists in the fields of botany, mammalogy, 13 ichthyology, entomology, ornithology, and invertebrate zoology. 14 The commission shall select its own chairperson." 15 SECTION 4. Section 197-4, Hawaii Revised Statutes, is 16 repealed. 17 ["\$197-4 Aquatic life and wildlife advisory committees. 18 (a) There is established in each of the counties of the State 19 an aquatic life and wildlife advisory committee. Each committee 20 shall be composed of members of the board representing the

1	members, and five members appointed by the governor in
2	accordance with section 26-34, who shall be knowledgeable in the
3	taking and conservation of aquatic life and wildlife. The
4	members shall serve for four-year terms. Each committee shall
5	select its own chairperson from its voting members, and three
6	voting members shall constitute a quorum. Members of the
7	committees shall receive no compensation but shall be reimbursed
8	by the board for all necessary expenses, including-stenographic
9	services.
10	(b) A committee shall meet at the call of its chairperson
11	or of any three of its members for the consideration of any
12	matter affecting the taking and conservation of aquatic life and
13	wildlife within the county, including proposed rules and the
14	enforcement thereof. Each committee may hear such persons and
15	acquire such information as it desires and shall communicate its
16	findings and recommendations to the department."]
17	SECTION 5. Statutory material to be repealed is bracketed
18	and stricken. New statutory material is underscored.

#### 19 SECTION 6. This Act shall take effect upon its approval.
