A BILL FOR AN ACT

MAKING AN EMERGENCY APPROPRIATION TO THE DEPARTMENT OF PUBLIC SAFETY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. This Act is recommended by the governor for
- 2 immediate passage in accordance with section 9 of article VII of
- 3 the Constitution of the State of Hawaii.
- 4 SECTION 2. Act 5, Session Laws of Hawaii 2019, as amended
- 5 by Act 7, Session Laws of Hawaii 2020, as amended by Act 9,
- 6 Session Laws of Hawaii 2020, deleted the base salary of 298.50
- 7 positions in the amount of \$17,972,111, general funds from the
- 8 fiscal year 2020-2021 budget of the department of public safety.
- 9 Specifically, 160.0 adult corrections officers' salaries were
- 10 deleted, totaling \$9,613,332.
- 11 The department of public safety operates eight separate
- 12 correctional institutions on Oahu and three neighbor islands, 24
- 13 hours a day, 7 days a week (24/7). A sufficient number of
- 14 trained security staff is required to safely operate these
- 15 secure institutions. The staff of 160.0 adult corrections
- 16 officers is necessary to ensure 24/7 security coverage
- 17 especially considering any response to the COVID-19 pandemic.

- 6 PSD 405- Hawaii Community Correctional Center: \$ 240,714
- 7 PSD 406- Maui Community Correctional Center: \$ 1,053,924
- 8 PSD 407- Oahu Community Correctional Center: \$ 1,620,912
- 9 PSD 408- Kauai Community Correctional Center: \$ 144,204
- 10 PSD 409- Women's Community Correctional Center: \$ 143,064
- 11 Additionally, staffing for the health care division which is at
- 12 the forefront of the department's response to the COVID-19
- 13 pandemic has been critically reduced with the deletion of the
- 14 base salary for 33.50 positions, of which, 26.50 are health care
- 15 professionals, including physicians, psychiatrists,
- 16 psychologists, registered nurses, para-medical assistants,
- 17 physical and occupational therapists, and psychiatric social
- 18 workers. The salary reduction for the 26.50 positions in PSD
- 19 421-Health Care for fiscal year 2020-2021 is \$2,400,451. The
- 20 department's pandemic response plan requires all health care
- 21 disciplines to provide health care service, assistance, and
- 22 monitoring capabilities in-house at all correctional

4	The purpose of this Act is to make an emergency appropriation to
5	the department of public safety to provide the correctional
6	institutions listed above and the health care division with
7	sufficient funds to cover the personnel costs associated with
8	the provision of 24/7 operations and response to the COVID-19
9	pandemic.
10	SECTION 3. There is appropriated out of the general
11	revenues of the State of Hawaii the sum of \$6,006,892 or so much
12	thereof as may be necessary for the department of public safety
13	to cover the costs of the personnel services shortfall for
14	fiscal year 2020-2021.
15	The sum appropriated shall be expended by the department of
16	public safety for the purposes of this Act.
17	SECTION 4. This Act shall take effect upon its approval.

TITLE:

A BILL FOR AN ACT MAKING AN EMERGENCY APPROPRIATION TO THE DEPARTMENT OF PUBLIC SAFETY.

PURPOSE:

To make an emergency appropriation to provide additional funds for the Department of Public Safety (PSD) to cover the personnel services shortfall at all its correctional institutions and health care division in fiscal year 2020-21.

MEANS:

Emergency appropriation of funds.

JUSTIFICATION:

Act 9, Session Laws of Hawaii (SLH) 2020, that amended Act 7, SLH 2020, and that amended Act 5, SLH 2019, deleted the salaries of 160.0 Adult Corrections Officer positions and 26.50 health care positions, creating a shortage in personnel services appropriation in fiscal year 2020-2021. Further, the COVID-19 pandemic response has increased the personnel services costs at all correctional institutions statewide and health care services.

Impact on the public: PSD's core mission is to uphold public safety. The public safety is compromised without sufficient funding for staffing PSD's secure facilities and its COVID-19 pandemic response.

Impact on the Department and other agencies: This request will allow PSD to continue to safely and securely operate its eight distinct correctional institutions statewide and effectively execute its COVID-19 pandemic plan.
