A BILL FOR AN ACT

RELATING TO THE HAWAII SCHOOL FOR THE DEAF AND BLIND.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. By August 1, 2021, the board of education shall 2 meet with alumni, student, and parent representatives of the 3 Hawaii School for the Deaf and Blind, other members of the 4 Hawaii deaf community, and representatives of the department of 5 education about progress toward a plan to convert the Hawaii School for the Deaf and Blind to a charter school and to discuss 6 7 alternatives, including an immersion school structure. 8 SECTION 2. By October 1, 2021, the department of 9 education, in consultation with alumni, student, and parent 10 representatives of the Hawaii School for the Deaf and Blind and 11 other members of the Hawaii deaf community, shall: Submit a letter of intent to an authorizer to convert 12 (1) the Hawaii School for the Deaf and Blind to a charter 13 14 school;
- 15 (2) Assist with the establishment of an applicant 16 governing board for the charter school; and

ı	(3) Develop a detailed implementation plan to transition

10			access to the same level of funding it has before	
11			conversion;	
12		(C)	Include a timeline for the school's transition to	
13			a conversion charter school; and	
14		(D)	List any additional funding necessary to	
15			transition the school to a conversion charter	
16			school.	
17	SECT	ION 3	. The department of education shall report to the	
18	legislature with the transition plan, funding requirements, and			
19	any proposed legislation no later than forty days prior to the			
20	convening	of t	he regular session of 2022.
