A BILL FOR AN ACT

RELATING TO THE BOARD OF EDUCATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. The legislature finds that teachers and school
 administrators are essential to student success. Yet, the board
 of education currently consists of nine voting members, none of
 whom are required to be a public school teacher or public school
 administrator.

6 The legislature further finds that the board of education 7 would benefit from the perspective of a public school teacher 8 representative and public school administrator representative by 9 providing insight into the:

- 10 (1) Educational and professional climate in Hawaii's11 public schools;
- 12 (2) Impact of education policies on teacher recruitment13 and retention; and
- 14 (3) Resources needed to deliver a quality learning15 experience to all of Hawaii's children.

16 The legislature additionally finds that the coronavirus17 disease 2019 pandemic (COVID-19) has significantly disrupted

1 Hawaii's public education system, forcing schools to adapt their 2 operations to protect public health. School communities were 3 required to adopt new protocols to deliver instructional 4 content, including comprehensive distance learning programs. 5 Board of education members and school administrators were also responsible for using medical information to make decisions 6 7 about school safety, such as when school campuses could safely 8 reopen and welcome the return of faculty and students. Board of 9 education deliberations about protocols and service delivery 10 systems developed in response to COVID-19 would also benefit 11 from the experience of a public school teacher representative 12 and public school administrator representative, given that 13 teachers spearhead classes and directly interact with students 14 and parents.

15 The purpose of this Act is to require the board of 16 education to invite:

17 (1) The exclusive representative for bargaining unit (5)
18 to appoint a nonvoting public school teacher
