# A BILL FOR AN ACT

RELATING TO THE DEPARTMENT OF LAND AND NATURAL RESOURCES.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that invasive species are 2 an immense threat to Hawaii's ecosystem. Invasive species cause 3 not only ecological damage, but harm to the environment, 4 economy, and human health. Hawaii's agriculture, tourism, 5 fisheries, and other industries, as well as its native forests 6 and water supply, suffer economic loss and deterioration due to 7 the negative impacts of invasive species on the environment. 8 The legislature also finds that many invasive plants are 9 extremely aggressive and out compete native plant species. 10 Invasion of non-native tree species like the albizia, ironwood, 11 and autograph trees have overtaken other native species in 12 Hawaii's forests and landscape. Albizia, like many other 13 invasive plant species, grows rapidly. Particularly during

14 storms, these invasive trees negatively impact drainage 15 facilities and waterways. Erosion caused by these trees also 16 affects water quality and causes flooding.

16		and clear hazardous tree growth;
17	(3)	Ways to restore native species and habitat conditions
18		in ecosystems that have been invaded; and
19	(4)	Flood control and other safety measures to address the
20		potential damage and damage caused to communities,

3 (c) The department of land and natural resources, in 4 conjunction with the counties, shall submit the plan, including 5 findings, recommendations, and any proposed legislation, to the 6 legislature no later than twenty days prior to the convening of 7 the regular session of 2022.
