- 5 for the purpose of financing capital improvement projects as

- 7 1. Iolani Palace, Oahu
- 8 Construction and equipment for

- of Iolani Palace.
- 11 Construction \$1,000,000
- 12 Total funding \$1,000,000
- 13 The sum appropriated for this capital improvement project
- 14 shall be expended by the department of land and natural
