
A BILL FOR AN ACT

PROPOSING AN AMENDMENT TO ARTICLE VIII, SECTION 3 OF THE HAWAII CONSTITUTION RELATING TO THE FUNCTIONS, POWERS, AND DUTIES OF REAL PROPERTY TAXATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that Hawaii has one of
- 2 the highest income tax rates and the lowest real property tax
- 3 rates in the nation. These tax strategies result in a
- 4 disproportionate amount of the overall tax burden being placed
- 5 on the residential workforce, who in turn effectively subsidize
- 6 non-residents' real estate investments in Hawaii.
- 7 The legislature further finds that removing the exclusivity
- 8 of county authority over real property taxes will provide the
- 9 State with greater flexibility and control of its taxation
- 10 policies.
- 11 The purpose of this Act is to propose an amendment to
- 12 article VIII, section 3, of the Constitution of the State of
- 13 Hawaii to repeal the exclusive authority of the counties to
- 14 exercise the functions, powers, and duties of real property
- 15 taxation, and thereby authorizing the State to also exercise
- 16 those powers.

- 1 SECTION 2. Article VIII, section 3, of the Constitution of
- 2 the State of Hawaii is amended to read as follows:
- 3 "TAXATION AND FINANCE
- 4 Section 3. The taxing power shall be reserved to the
- 5 State, except so much thereof as may be delegated by the
- 6 legislature to the political subdivisions, and except that [all]
- 7 functions, powers and duties relating to the taxation of real
- 8 property [shall] may be exercised [exclusively] by the counties,
- 9 with the exception of the county of Kalawao. The legislature
- 10 shall have the power to apportion state revenues among the
- 11 several political subdivisions."
- 12 SECTION 3. The question to be printed on the ballot shall
- 13 be as follows:
- "Shall the exclusivity of the counties as to the functions,
- 15 powers, and duties relating to the taxation of real property be
- 16 repealed and the State be authorized to also exercise the
- 17 functions, powers, and duties relating to the taxation of real
- 18 property?"
- 19 SECTION 4. Constitutional material to be repealed is
- 20 bracketed and stricken. New constitutional material is
- 21 underscored.
