A BILL FOR AN ACT

RELATING TO CRIME.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature acknowledges the harmful
- 2 effects of illegal gambling and drug houses in communities
- 3 across the State. These effects include an increase in other
- 4 criminal activities such crimes of violence and sex trafficking.
- 5 The legislature believes that rather than attempting to
- 6 address these criminal activities in a piecemeal fashion, an
- 7 intergovernmental task force encompassing federal, state, and
- 8 city agencies should be established to engage in an organized,
- 9 collaborative effort to examine relevant issues, determine the
- 10 resources needed to address these issues, and devise a
- 11 coordinated action plan.
- 12 Accordingly, the purpose of this Act is to establish a
- 13 special intergovernmental task force to eradicate illegal
- 14 gambling and drug activities and to establish community safe
- 15 zones across the State.
- 16 SECTION 2. (a) There is established within the department
- 17 of the attorney general for administrative purposes a special

3	(b)	The task force shall consist of the following members:
4	(1)	The state attorney general or the attorney general's
5		designee, who shall serve as chair of the task force;
6	(2)	The director of public safety or the director's
7		designee;
8	(3)	The director of transportation or the director's
9		designee;
10	(4)	The respective chiefs of police of the counties of
11		Hawaii, Maui, Kauai, and of the City and County of
12		Honolulu, or their designees; and
13	(5)	The respective directors of the planning or permitting
14		agencies of the counties of Hawaii, Maui, Kauai, and
15		of the City and County of Honolulu, or their
16		designees.
17	(c)	Representatives from the following entities shall be
18	invited t	o participate by the chair of the task force:
19	(1)	The office of the United States attorney for the

district of Hawaii, and if participating, the

representative shall be invited to serve as vice chair

1		of the task force; provided that the state attorney
2		general shall designate another task force member to
3		serve as vice chair if necessary;
4	(2)	The United States Department of Homeland Security;
5	(3)	The United States Drug Enforcement Agency;
6	(4)	The Federal Bureau of Investigation; and
7	(5)	Any governmental or private entity deemed relevant by
8		the chair of the task force.
9	(d)	The task force shall dedicate itself to the
10	eradicati	on of illegal gambling and drug activities in the
11	State. A	ccordingly, the task force shall engage in an
12	organized	, collaborative effort to examine relevant issues,
13	determine	the resources needed to address these issues, and
14	devise a	coordinated action plan. Activities of the task force
15	shall inc	lude:
16	(1)	Establishing, under the department of the attorney
17		general, a statewide program to identify and eliminate
18		illegal gambling houses and drug houses; and
19	(2)	Establishing community safe zones throughout the State
20		for the purpose of enforcing zoning and other
21		restrictions on lands that may be used for gambling

1	activities, including casino gaming, regardless of
2	whether the activities are legal or illegal; provided
3	that the task force shall endeavor to establish, at a
4	minimum, a requirement that lands that may be used for
5	any type of gambling activity, and any structures
6	thereupon, be situated more than ten thousand feet
7	away from churches, schools, and residential areas;
8	provided further that the task force shall also
9	endeavor to establish an appropriate enforcement
10	mechanism for this requirement.

- 11 (e) The chair and vice chair of the task force shall
 12 oversee the activities of the task force and lead the decision13 making of the task force members.
- (f) The task force shall submit a report of its findings and recommendations, including any proposed legislation, to the legislature no later than twenty days prior to the convening of the regular session of 2022.
- 18 (g) The members of the task force shall serve without
 19 compensation and shall receive no reimbursement for expenses.
- (h) The members of the task force shall not be consideredemployees for the purposes of chapter 84, Hawaii Revised

- 1 Statutes, based solely upon their participation in the task
- 2 force.
- 3 (i) The task force shall be dissolved upon adjournment
- 4 sine die of the regular session of 2022.
- 5 SECTION 3. This Act shall take effect upon its approval.
