A BILL FOR AN ACT

RELATING TO EMERGENCY MEDICAL SERVICES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	PART I
2	SECTION 1. Chapter 46, Hawaii Revised Statutes, is amended
3	by adding a new part to be appropriately designated and to read
4	as follows:
5	"PART .
6	COUNTY EMERGENCY MEDICAL SERVICES SYSTEM
7	§46- Definitions. As used in this part, unless the
8	context clearly requires otherwise:
9	"Advanced life support" means initiating all basic life
10	support care as well as invasive patient care designed to
11	stabilize and support a patient's condition due to sudden
12	illness or injury. The care rendered, excluding basic life
13	support, constitutes the practice of medicine.
14	"Basic life support" means initiating noninvasive emergency
15	patient care designed to optimize the patient's chances of
16	surviving the emergency situation. The care rendered consists
17	of all first-aid procedures needed, but does not include

- 1 invasive procedures that constitute the practice of medicine;
- 2 provided that state-approved basic life support personnel may
- 3 use fully automatic external defibrillators, initiate
- 4 intravenous lines, and perform manual external defibrillation
- 5 under the direction and personal supervision of a mobile
- 6 intensive care technician and in accordance with rules adopted
- 7 by the department.
- 8 "Community paramedicine program" means an enhanced and
- 9 expanded service in the county emergency medical services system
- 10 that allows state-licensed health care professionals and
- 11 community health workers to assist with public health, primary
- 12 care, and prevention services, including services through
- 13 telehealth.
- "County" means any county having a population of five
- 15 hundred thousand or more.
- "County system" means the county emergency medical services
- 17 system.
- "Emergency aeromedical services" means a secondary response
- 19 system that provides immediate critical care and transport by
- 20 rotary-wing aircraft of a patient to a facility that provides
- 21 specialized medical care.

1 "Emergency medical services for children" means emergency 2 medical services including preventive, pre-hospital, hospital, 3 rehabilitative, and other post-hospital care for children. 4 "Emergency medical services personnel" means any mobile 5 intensive care technician or emergency medical technician who is 6 certified or licensed by the State. 7 **§46-**County emergency medical services system; 8 establishment. Each county shall establish, administer, and 9 maintain a county emergency medical services system to serve the 10 emergency health needs of the people in the county. The county, 11 in the implementation of this part, shall plan, coordinate, and 12 provide assistance to all entities and agencies, public and 13 private, involved in the county system. All emergency medical 14 services or ambulance services conducted by or under the 15 authority of the county shall be consistent with this part. 16 **\$46-**County, functions; duties. In addition to other 17 functions and duties assigned under this part, the county shall: 18 (1) Establish emergency medical services in the county, 19 including emergency aeromedical services, which shall 20 meet the requirements of this part;

- 7 SECTION 2. Chapter 321, Hawaii Revised Statutes, is
- 8 amended by adding a new section to part XVIII to be
- 9 appropriately designated and to read as follows:

- 12 SECTION 5. Section 321-223, Hawaii Revised Statutes, is

11		first-aid, and the availability of first-aid training
12		programs in the [State;] service area;
13	(10)	Establish standards and provide training for
14		dispatchers in the [state system,] service area, and
15		maintain a program of quality assurance for dispatch
16		equipment and operations;
17	(11)	Establish a program that will enable emergency service
18		personnel working in the service area to provide early
19		defibrillation;
20	(12)	Establish within the department the emergency medical
21		service system for children[+] in the service area;

- 4 SECTION 14. Section 321-229, Hawaii Revised Statutes, is
- 5 amended by amending subsections (a) and (b) to read as follows:
- 6 "(a) The University of Hawaii shall provide training
- 7 courses in basic, intermediate, and advanced life support for
- 8 emergency medical services personnel. The curricula and syllabi
- 9 of these courses shall be approved in advance by the department
- 10 [of health.] and by any county operating a county emergency
- 11 medical services system pursuant to part of chapter 46. The
- 12 curricula and syllabi of courses for ambulance personnel shall
- 13 be consistent with the scope and level of the practice of
- 14 emergency medical services associated with emergency ambulance
- 15 personnel certification defined by the Hawaii medical board
- 16 under part II of chapter 453.
- 17 (b) The University of Hawaii, or other accredited
- 18 community college, college, or university, or any professional
- 19 organization that is approved by the department [of health] to
- 20 provide emergency medical services training, shall consult with
- 21 the department [of health] and any county operating a county

1 emergency medical services system pursuant to part of 2 chapter 46 to determine the number and type of emergency medical 3 services courses necessary to support the staffing requirements 4 for emergency medical services. The basic life support and 5 advanced life support training programs shall be relevant to and consistent with the training course required for certification 7 under chapter 453." SECTION 15. Section 321-230, Hawaii Revised Statutes, is 8 9 amended by amending subsections (a) and (b) to read as follows: 10 The department may contract for technical assistance 11 and consultation, including [but not limited to] categorization, 12 data collection, and evaluation appropriate to the needs of 13 emergency services within the [state system.] State. 14 collection and analysis of statewide emergency medical services 15 data, including pediatrics, trauma, cardiac, medical, and 16 behavioral medical emergencies, shall be for the purpose of 17 improving the quality of services provided. 18 The department may implement and maintain a trauma registry 19 for the collection of information concerning the treatment of 20 critical trauma patients at state designated trauma centers, and

carry out a system for the management of that information. The

21

- 1 system may provide for the recording of information concerning
- 2 treatment received before and after a trauma patient's admission
- 3 to a hospital or medical center. All state designated trauma
- 4 centers shall submit to the department [of health] periodic
- 5 reports of each patient treated for trauma in the state system
- 6 in [such] the manner as the department shall specify.
- 7 For the purposes of this subsection, "categorization" means
- 8 systematic identification of the readiness and capabilities of
- 9 hospitals and their staffs to adequately, expeditiously, and
- 10 efficiently receive and treat emergency patients.
- 11 (b) The department shall establish, administer, and
- 12 maintain an aeromedical emergency medical services system
- 13 designed to collect and analyze data to measure the efficiency
- 14 and effectiveness of each phase of [an] the emergency
- 15 aeromedical program[-] established by the department and any
- 16 emergency aeromedical program that may be established by any
- 17 county operating a county emergency medical services system
- 18 pursuant to part of chapter 46.
- 19 The aeromedical emergency medical services system shall
- 20 serve the emergency health needs of the people of the State by
- 21 identifying:

- 1 (1) The [system's] strengths and weaknesses[+] of
 2 aeromedical emergency medical services with the State;
- 3 (2) The allocation of resources; and
- 4 (3) The development of rotary-wing emergency aeromedical
- 5 services standards;
- 6 provided that emergency helicopter use, including triage
- 7 protocols, shall be based on national aeromedical triage and
- 8 transport guidelines established by the Association of Air
- 9 Medical Services, the American College of Surgeons and the
- 10 National Association of Emergency Medical Service Physicians.
- 11 The department, in the implementation of this subsection, shall
- 12 plan, coordinate, and provide assistance to all entities and
- 13 agencies, public and private, involved in the system."
- 14 SECTION 16. Section 321-232, Hawaii Revised Statutes, is
- 15 amended as follows:
- 16 l. By amending subsection (a) to read:
- "(a) The department [of health] shall establish reasonable
- 18 fees for services rendered to the public within the service area
- 19 by the department [of health], any county $[\tau]$ within the service
- 20 area, or private agency under this part; provided that all
- 21 [such] revenues [which shall be] collected by the department [of

- 1 health] and the respective counties pursuant to this section
- 2 shall be deposited into the state general fund, except [such]
- 3 amounts necessary to provide for collection services for bad
- 4 debt accounts. Fees required to be set by this section shall be
- 5 established in accordance with chapter 91."
- 6 2. By amending subsection (c) to read:
- 7 "(c) In the event of nonpayment of any fees required to be
- 8 assessed by this section, the department [of health] shall
- 9 determine whether the recipient of [such] services is
- 10 financially able to pay [such] the fees and make every
- 11 reasonable effort to collect [such] the fees. In the event the
- 12 department finds the person is without sufficient resources to
- 13 pay for the services, no further action to collect the fees
- 14 shall be taken. If the services are paid by a county or any
- 15 other entity, and collection of [such] the fee is delegated by
- 16 contractual agreement to the county or other agency [which] that
- 17 provides the services, the county or other agency shall forward
- 18 records relating to unpaid fees for action by the department [of
- 19 health] under this subsection. No county or other entity shall
- 20 make a final determination of the ability of a person to pay
- 21 under this subsection. Any determination of ability to pay for

- 1 purposes of this subsection shall be in accordance with rules
- 2 [which] that the department [of health] shall adopt, subject to

- 4 SECTION 17. Section 321-236, Hawaii Revised Statutes, is

- 7 gloves prohibited. The use of latex gloves by personnel
- 8 providing ambulance services or emergency medical services
- 9 within the service area pursuant to this part shall be
- 10 prohibited."
- 11 PART II
- 12 SECTION 18. (a) The transition of all rights, powers,
- 13 functions, and duties of the department of health under
- 14 part XVIII of chapter 321, Hawaii Revised Statutes, that are
- 15 exercised within the island of Oahu are hereby transferred to
- 16 the city and county of Honolulu and such transition shall
- 17 commence with the transfer of all training and billing for
- 18 emergency services on July 1, 2021. The transition of all
- 19 rights, powers, functions, and duties of the department of
- 20 health under part XVIII of chapter 321, Hawaii Revised Statutes,

- 1 to the city and county of Honolulu shall be completed no later

6	SECTION 19. Notwithstanding any other provision of this
7	Act or other law to the contrary, any member of the state
8	emergency medical services advisory committee who resides in the

Establishes a four-year transfer of certain duties, functions, and powers relating to emergency medical services for the city and county of Honolulu from the department of health to the city and county of Honolulu. Begins transition with the training and billing for emergency services on 7/1/2021. Appropriates general funds to the city and county of Honolulu for emergency medical services for fiscal years 2021-2022 and 2022-2023. Appropriates half of the moneys in the emergency medical services special fund to the general for fiscal years 2021-2022 and 2022-2023. Phases out state funding for emergency medical services in the city and county of Honolulu by 6/30/2025. (HD1)
