

A BILL FOR AN ACT

RELATING TO EMERGENCY PREPAREDNESS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The legislature finds that the community
2	assessment for public health emergency response (CASPER) is a
3	low-cost, validated two-stage cluster sampling methodology
4	developed by the Centers for Disease Control and Prevention to
5	rapidly obtain information about the health and resource needs
6	of a community. Information obtained is generalizable to the
7	entire sampling frame providing population-based estimates. The
8	information generated by this rapid needs assessment can be used
9	to initiate public health action, identify information gaps,
10	facilitate disaster planning and response activities, allocate
11	resources, and assess new or changing needs in the community.
12	The legislature also finds that although the department of
13	health has offices in every county, only the Kauai district
14	health office has conducted CASPERs annually from 2017 through
15	2019 to monitor trends in the emergency preparedness of island
16	residents. This resource was tapped during the coronavirus
17	disease 2019 (COVID-19) response effort on Kauai to determine

- 1 the impacts of the pandemic on the community. The county's
- 2 emergency management agency developed a survey, which assessed
- 3 the community's knowledge, attitudes, and practices about COVID-
- 4 19, as well as the financial and mental health impacts on
- 5 households.
- 6 The legislature further finds that, aside from the Kauai
- 7 data collected, there is almost no data about household level
- 8 emergency preparedness in Hawaii at either the county or a
- 9 statewide level. For example, data on household food storage, a
- 10 critical element of food system resilience, could serve as a key
- 11 data point for both immediate response planning and long-term
- 12 intervention planning.
- 13 Accordingly, the purpose of this Act is to require the
- 14 department of health to conduct:
- 15 (1) A CASPER assessment for each county; and
- 16 (2) A statewide CASPER assessment,
- 17 to determine key emergency preparedness facets that would
- 18 articulate key vulnerabilities to aid county and state recovery
- 19 response and recovery planning.

- 13 department staff and volunteers who conduct the survey shall
- 14 follow social distancing requirements and provide for the
- 15 ability for selected households to participate via telephone.
- 16 (f) The department of health shall obtain consent from all
- 17 participants and provide for the opportunity to participate in a
- 18 socially distanced outdoor or telephone interview.
- 19 (g) The department of health shall provide for educational
- 20 materials on COVID-19 and available social service resources for
- 21 households who seek to participate in the study.

1	SECTION	3.	The	department	of	health	shall	submit	a	report

- 2 of its findings and recommendations from the CASPER analyses,
