## A BILL FOR AN ACT

RELATING TO FIREWORKS.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Section 132D-8.6, Hawaii Revised Statutes, is 1 2 amended by amending subsection (b) to read as follows: 3 "(b) The harbors division of the department of 4 transportation shall inspect for possible violations of this 5 chapter any shipment that has landed at a commercial harbor 6 within the jurisdiction of the division and originating from a geographic location that is known to manufacture, use, or export 7 8 aerial fireworks; provided that the harbors division shall 9 perform these inspections using specialized canine units that 10 have been trained in identifying explosives, gun powder, and 11 other explosive agents commonly used in fireworks; provided 12 further that the fire department of a county $[\tau]$  in which a 13 shipment of fireworks or articles pyrotechnic has landed and 14 becomes subject to the jurisdiction of the fire department  $[\tau]$ [shall be allowed to] may inspect[, if it chooses,] any shipment 15 16 declared on the shipping manifest as fireworks or articles 17 pyrotechnic."

1 SECTION 2. There is appropriated out of the general 2 revenues of the State of Hawaii the sum of \$ or so much 3 thereof as may be necessary for fiscal year 2021-2022 and the 4 same sum or so much thereof as may be necessary for fiscal year 5 2022-2023 for the harbors division of the department of 6 transportation to establish specialized canine units on each 7 island containing a commercial harbor within the division's 8 jurisdiction; provided that each canine unit shall be trained in 9 identifying explosives, gun powder, and other explosive agents 10 commonly found in fireworks.

11 The sums appropriated shall be expended by the department 12 of transportation for the purposes of this Act.

13 SECTION 3. Statutory material to be repealed is bracketed14 and stricken. New statutory material is underscored.

15 SECTION 4. This Act shall take effect on July 1, 2021.
